Special Instructions

- 1- The applicant must possess prescribed qualifications, age and experience on the last date of **on-line submission** of applications. If on verification, at any time before or after the written examination or interview or appointment, it is found that they do not fulfil any of the eligibility condition or it is found that the information furnished is false or incorrect, their candidature will be cancelled. **However, for the post of Assistant Prof./equiv; the consideration of Ph.D degree will be upto the date of interview subject to submission of thesis as on the last date of receipt of application and production of provisional degree certificate at the time of interview. The publication will also be considered upto the last date of on-line submission and no further addition/correction will be entered through any other mode.** The prescribed essential qualification does not entitle a candidate to be called for interview. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.
