1. The Doctor must be MBBS and registered with SMC/MCI. Attach Proof

2. The hospital of the doctor should not be more than 5 KM away from CCSHAU Campus, Bawal

3. The hospital/doctor will provide free ambulance services to the students and staff from hostel/campus to his hospital in case of emergencies

The doctor will make 3 visits each of 2 hrs during a week on alternate days. The timings will be decided keeping in view the convenience of students and staff of CCSHAU Bawal campus

The doctor will provide nursing staff from 9 AM to 5 PM daily for first aid and providing medicine as prescribed by the doctor

The doctor will not charge OPD/consultancy charges if any from student/staff members of CCSHA Bawal visit the hospital for check up/consultancy

7. Preference will be given to hospital/doctor who can arrange the visit of a lady doctor at least once a week.

Tender will be received by the office of Principal CCSHAU COA Bawal up to 5.00 PM on 16.08.2021 and will be opened by committee in the O/o DSW CCSHAU, Hisar on 18.08.2021 at 11.00 AM in the presence of such tenders or their agents who may like to present.

9. In case tender forms are downloaded from the official website of CCS HAU Hisar, duly filled tender form should be accompanied by a Demand Draft of Rs. 100/- in favour of Principal COA, Bawal

- 10. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and contractor will be black listed. The remaining job shall be got done at the risk and the cost of the contractor who has defaulted
