**AUCTION NOTICE**

In field no. 16/1 of Forestry Department research area (adjacent to Horticulture department research area; Ludas road), 255 plants are in fruiting. Department will record only the kinnow fruit yield per plant/hectare. The department will disposed off the kinnow fruits **only through sealed tenders on 11.11.2021 at 11.00 A.M.** The interested persons may please see the kinnow plants before participating in the auction on any working day (9.00 A.M. to 5.00 P.M) and avail the opportunity. The quotation should be reached in the office of Forestry Department **onlythrough speed post/courier up to 10.11.2021 up to 4.00 P.M.**

**TERMS AND CONDITIONS**

1. The bidders will have to attach the earnest money of Rs.2, 000/- in the shape of Demand Draft along with the tender application in favour of Professor and Head, Department of Forestry, CCS HAU, Hisar payable at SBI, HAU Branch, Hisar. The tender application can be obtained from the office of Forestry Department by paying Rs. 100/- only.
2. 25% of the bid value will have to be deposited by highest bidder with the receipt of official orders and the remaining amount will have to be paid before taking over the management of kinnow plants, failing which the earnest money will be forfeited. An amount of Rs. 10,000/- (Rs. Ten thousand only) will have to be deposited as security before the start of look after of the plants.
3. **The tenders will not be accepted after 10.11.2021 at 4.00 p.m.and the tenders received will be opened next day on 11.11.2021 at 11.00 A.M.**
4. After the auction, the department will not be responsible for loss of material mentioned.
5. The kinnow will be sold "as is where basis" and all the management practices (insecticide/pesticide spray) will be made by the purchaser himself.
6. The auction committee reserves the right to accept or reject the highest bid without assigning any reason thereof.
7. The earnest money (Demand Draft) of the unsuccessful bidder will be given back through post after the finalization of the successful bid and no interest will be paid on the same.
8. The security money shall be adjusted/refunded only after producing the NO DUES CERTIFICATE from the Farm Area In-charge/supervisor of Department.
9. The delivery will be F.O.R. HAU, Hisar on "AS IS WHERE IS BASIS".
10. The department will not be responsible for postal/courier delay of the tender application.
11. In case of any dispute, the decision of the Committee shall be final.
