- 3. Tenders not accompanied with earnest money in the shape of National Plan Certificate or deposited at call receipt at any schedule bank at KARNAL and the amount of earnest money pledged to the REGIONAL DIRECTOR, CCS HAU, RRS KARNAL shall not be considered. In case of non-acceptance of the tenders, the amount shall be refunded to them on the same day.
