**AUCTION NOTICE**



Two shisham trees having approximate volume 5.52 cubic meters will be sold 'As is where is' through open auction to be held at the Research Farm of Pulses Section, Dept. of Genetics & Plant Breeding, CCS HAU, Hisar on 24.01.2022 at 10.00 a.m. The reserve price for auction will be Rs. 72,429/- (Seventy two thousands four hundred and twenty nine only). All the interested parties are requested to avail the opportunity.

**Terms and conditions:**

1. The bidder will be required to deposit a sum of Rs. 10,000/- (Ten thousands only) as security before giving the bid which will be refunded/ adjusted in the amount of bid on the spot.
  2. Before participating in the auction, bidders shall have to deposit earnest money as mentioned in cash or by bank draft in favour of 'Head Pulses Section'. No cheque will be accepted.
  3. 25% amount of the bid accepted will have to be deposited at fall of the hammer and rest of the amount before lifting the trees.
  4. GST charges will be charged as per norms.
  5. The successful bidders will have to lift whole of the articles from the auction site within three days.
  6. Transportation of material shall be arranged by the purchaser himself.
  7. In case of any dispute, the decision of the Controlling Officer will be final and binding.
  8. Dispute if any, shall be subject to Hisar Court of Law.
  9. In the event of backing out of the bid, the successful bidder shall be responsible to pay damages to the university in addition to the forfeiture of the security amount.
  10. The auction committee will have the right to accept or reject any bid without assigning any reason thereof.
  11. The employees of the department will not be allowed to bid.
  12. Other terms & conditions will be announced by the Auction Committee at the time of auction.
  13. Interested parties / persons are invited to bid at site on the above said date and time.


