### NOTICE FOR INVITING TENDERS FOR THE EXECUTION OF THE CONTRACT WORK

1. Name and address of the office :

Landscape Unit, CCS HAU, Hisar

2. Job Description :

1. Cleaning of curbs & channel from grass and weeds towards roads.  
(i) From gate No.03 to COA Chowk, upto AFT building burm & Both sides.  
(ii) From Gate No.02 to Shopping center, Campus school & upto VC LUVAS Office both sides.
2. Cleaning and uprooting of unwanted vegetative growth, maintenance of Hostel lawns and surrounding area & unforeseen work as per requirement.

3. Duration of Contract : 16.08.2022 to 31.10.2022

4. Estimated cost : Rs.214812/-

5. Earnest money : Rs.4300/-

6. Date of opening of tender : 16.08.2022 at 4:30 p.m.

7. Working hours : University working hours

#### TERM & CONDITIONS OF THE TENDER

1. Sale of tender forms is available during office hours from 9.00 a.m. to 5.00 p.m. in the Old Nursery of this Unit by paying Rs. 118/- (Rs.100 +18%GST) on any working day upto **16.08.2022** at 12.00 noon. The Tender may be deposited upto 1.00 PM on **16.08.2022**.
2. In case of date of opening of the tender happens to be holiday tender will be received and opened on next day.
3. Tender will be submitted in two envelopes by the tenderers. One envelope consists of Earnest Money only and 2<sup>nd</sup> envelope containing tender documents. 2<sup>nd</sup> envelope will be opened and rejected if first envelop does not contain earnest money
4. Earnest money must be deposited in the shape of bank demand draft in favour of Head , Landscape Unit. Cash deposit will not be accepted.
5. No conditional tender will be accepted.
6. The contractor shall be required to sign the contract agreement on bond paper of Rs. 15/- on the prescribed form within ten days of the intimation of the acceptance of tender to him. Failure on his part to do so may result in invalidation of the contract and forfeiture of the earnest money.
7. Income tax @ 2% to be deducted from the bills at source.
8. The contractor will have to execute the job within the given time and no request for extension for time shall be entertained except in unforeseen circumstances.
9. Payment will be made as per execution of work satisfactorily.
10. The acceptance of the tender will rest with committee who does not bind itself to accept the lowest tender and reserves the authority to reject any or all tenders without assigning any reason therefore. All tenders in which the conditions are not fulfilled will be rejected.
11. The contractor shall be responsible for observance of the Provisions of the Contract Labour (Regulation and Abolition) Act, 1970. The University shall not be responsible for it in any manner.
12. In case of any loss due to negligence of contractual workers or harm of university property, the contractor shall be responsible to make good loss to the Landscape Unit, failing which the amount of loss shall be recovered /adjusted from earnest money.
13. It will be sole responsibility of the contractor to compensate the labour because of injury, loss of life or limb in accordance with the law in force for the time being. The University will in no way be responsible for such loss.
14. The contractor shall be required to provide small agril. Implements (Hand tools) i.e. Kassi, Kasola and Dranti etc. required by the labourers. He will have to work as per instructions given by the Head, Landscape Unit/Agril. Inspector/S.Os. on the site.
15. It will be the responsibility and liability of the contractor to adhere to the provisions of the ESI and Provident Fund Act and in case they are not followed properly, he himself will be responsible for it.
16. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and the contractor will be blacklisted. The remaining job shall be got done at the risk and cost of the contractor

17. who has defaulted. The university reserves the right of supervision. Transport for transporting labour will not be provided by the University.
18. The parties may visit the site of contact for this purpose before submitting their tenders on any working day before deposit dated time of tender.
19. The contractor should not use insulting language against any worker/supervisor.
20. The contractor must issue attendance card and identity card to each worker employed by him in connection with field operational work so that record pertaining to the attendance of workers should be in the notice of workers.
21. As per the provision in the Contract Labour Act, 1970, the contractors shall be responsible for the payment of wages as per Govt. approved rates before expiry of such period as may be prescribed. Any litigation arise due to non-compliance of above conditions will be responsibility of the contractor and will be settled by him.
22. Contractors may give break up of wages, PF and ESI in the tender to be offered by them pertaining to field operational work. They may obtain the PF and ESI code from competent authority.
23. It will be sole responsibility of contractor to supply copy of challan regarding PF/ESI.
24. Workmen deployed through contractors for field operational work will abide by the following provisions strictly:-
- a Workers are paid wages by 7<sup>th</sup> of every month by contractor.
  - b Workers are paid the fixed minimum wages or DC rate whichever is higher as per Haryana Govt. directions.
  - c Wages slip is issued regularly to the workers by the contractors.
  - d Necessary certificate regarding the above provisions (a to c) be also got recorded in the wages register from Principal Employer or the person who is authorized in this behalf by the Principal employer
25. If the contractor employees 20 or more than this in a particular contract then he should obtain licence from the Labour Department and submit the same to the Principal Employer. Enclose a photocopy of licence along with tender offered.
26. Contractor should obtain licence from the Labour Department and submit the same to the Principal Employer.
27. The tenders of contractors having PF, ESI code may be accepted in response to tender notice and in case the contractors do not have any code, they should obtain the code from the competent authority.
28. In case it is observed that the party above pooled their rates quotes are liable to be black listed.
29. In case of any dispute the same will be referred to arbitration to the Vice-Chancellor and his decision shall be final. The provision of Indian arbitration Act shall applied to these proceedings.
30. The workman deployed through the contractors for field operational work may be paid the fixed minimum wages or DC rate whichever is higher as per provisions of Haryana Govt. and that provision of working hours may be fixed for them. EPF provisions may also be followed strictly by the contractors. The worker may also be paid wages well in time every month, besides to issue wages slip to them.
31. The tenderer should quote the amount in lump sum for the work mentioned above.
