No. 28/01/2006-1HR-I -It is hereby notified that 22.11.2022 (Tuesday) and 25.11.2022 (Friday) shall be observed as Public holiday in all offices, Educational and other institutes of the Government of Haryana, Board & Corporations situated in the jurisdiction of the areas namely Faridabad, Fatehabad, Hisar and Palwal to enable employees of aforesaid institutions/offices etc. to cast their votes for Members of Zila Parishads and Panchayat Samitis and also for those employees located/working beyond the jurisdiction of said Zila Parishads and Panchayat Samitis but are registered voters of said areas.

It is also notified that 22.11.2022 and 25.11.2022 shall also be observed as Paid holiday under section 135B of the Representation of People Act, 1951 applicable under Section 173A of the Haryana Panchayati Raj Act, 1994 and under section 25 of Negotiable Instrument Act, 1881 for all the factories, Commercial, Establishments, industrial undertakings, trade, shops, Banks etc., falling within the jurisdiction, where poll shall be held on 22.11.2022 and 25.11.2022 to enable workers of these factories, Commercial Establishments, industrial undertakings, trade shops, Banks etc. located in the areas of the aforesaid Panchayati Raj Institutions to cast their votes.
