



WORK NOTICE

The Krishi Vigyan Kendra, Sadalpur (Hisar) is inviting sealed tender for leveling work in 2 acres area in field No.2 & 9 in western side of water harvesting tank at its Farm. The application form can be received from KVK, Sadalpur (Hisar) by paying Rs. 100/ application form from dated 13.03.2023. The duly filled Quotation form should be reached in KVK office through speed post/courier/by hand on or before 20.03.2023 up to 12.30 pm and the Quotations will be opened on the same day at 2.30 pm in the presence of all the bidders and committee members. Detail of the work:

Terms and Conditions

1. The bidders will have to attach the earnest money of Rs. 2,000- (Rs. two thousand only) in the shape of cash along with the work application form in favour of coordinator. KVK Sadalpur, Hisar. The work application form can be received from KVK Sadalpur by paying Rs. 100/application.
2. The quotation should be reached in the office of Krishi Vigyan Kendra Sadalpur, Hisar by speed post/courier/by hand with in the given time (20.03.23 upto 12.30 pm).
3. The auction committee reserves the right to accept or reject the lowest bid without assigning any reason thereof.
4. If the bidder fails to execute the works than the security will be forfeited and work will be allotted to second lowest bidder
5. The earnest money of the unsuccessful bidder will be given back after the finalization of the successful bid and no interest will be paid on the same.
6. The successful bidder will have to start the leveling work within two days after the date of opening of bid and it should be completed within 10 days after start of work or before 31.03.2021, which one is earlier. However, the Coordinator KVK Sadalpur, Hisar can extend the time in exceptional cases only.
7. The security /earnest money shall be refunded only after producing the NO DUES CERTIFICATE from the Farm Area In-charge of KVK.
8. The department/Centre will not be responsible for postal/courier delay of the tender application.
9. In case of any dispute, the decision of the Committee shall be final.
10. All the disputed cases shall be subject to Hisar jurisdiction.
11. The KVK will not be responsible for any type of damage in machinery and misshaping.
