Terms and Conditions:-

1. The appointment is co-terminus with the project. The term of the appointment in one time will be for one year or termination of the project or upto 31.03.2024, whichever is earlier. However, in the case work and conduct is not found satisfactory, his/her services can be terminated after giving the opportunity. If he/she wants to leave, he/she can do after giving one month notice or one month emoluments in lieu thereof to the University. The maximum duration of engagement of Young Professional is three years (1+1+1)/duration of research project whichever is earlier.
2. The services of employee will also be liable to terminate any appoint of time without assigning any reason because of non release grant by funding agency or owing to administrative reason by issue to one month notice or one month emoluments in lieu thereof.
3. On expiry of the term of the project, he/she will be relieved and the University/department/KVK will not responsible for his/her adjustment in the University.
4. He/she will not be regular employee of the University and would not be entitled to any CPF/GPF or any other benefit admission to regular employees.
5. He/She will be required to produce a medical certificate of fitness from the CMO, CCS HAU, Hisar at the time of joining.
6. He/She would report for duty within 15 days from the date of issue of engagement/appointment order failing which per appointment will be treated as withdrawn.
7. His/her place of work will be KVK, Sirsa for YP-II. However, he/she can be transferred at any place in the interest of University work.

8. He/She will be required to execute an agreement on a non-judicial stamp paper of Rs.15/- before he/she is allowed to join the post.
9. Ph.D. students have to produce NOC from the Dean, PGS at the time of interview.
10. YP's will be under the administrative control of PI.
11. YP's will be entitled for leave as per university norms.
12. Their engagement for the scheme will be full time. They will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.
13. YP's will be subject to the laws of secrecy of the country and will sign a declaration of secrecy and non disclosure agreement before reporting.
14. The engagement will not constitute a regular job or appointment of any nature in the University.
15. During the terms of engagement they shall comply with the Standards of Conduct. Failure to comply the same will become a ground for termination without notice.
16. This University may modify, add, delete and/or amend/change the rules with the approval of the Vice-Chancellor, CCS HAU, Hisar.
17. This University reserves the right to withdraw the notification without assigning any reason.

Important:-

- (i) Application without the prescribed form/format will squarely be rejected.
- (ii) Candidate who wants to apply both positions must submit separate application for each post. One application will be treated for one post and one application for both posts will not be considered either of them and application will stand cancelled.
- (iii) For any update in this regard candidates may keep in touch with University website.
- (iv) The candidates who have applied earlier vide Notification No. 10576-675 dated 22.09.2022 on the above said posts are not need to apply again. Their earlier application will be considered.
