It is hereby notified that the following items will be put for auction on "as is where is basis" in the premises of Directorate of Farms, Balsamand Road, CCS Haryana Agricultural University, Hisar. The item can be inspected/seen in the office during working hours of this office on or before 26.02.2024. Earnest money of items will have to be deposited in the shape of Demand Draft to the Cashier of this office before taking part in the auction. Other terms and conditions, if any, will be announced by the committee at the time of auction.

Terms & Conditions:

1. The sealed quotations will be submitted in the Directorate of Farm on or before 26.02.2024. The committee will open the received quotations on date 27.02.2024 at 11:00 AM in the Office of Director Farms in presence of bidders who may be present. The envelope containing the quotations should be super scribed the work "Directorate of Farms, CCS HAU, Hisar Rate for Diesel including sludge".
2. Conditional quotations and quotations without earnest money are liable to be rejected.
3. Before participating in the auction, bidders shall have to deposit earnest money as mentioned against items in shape of Demand Draft in favour of "Director Farms, CCSHAU, Hisar" payable at Hisar. No cheque will be accepted.
4. Sealed bid is to be deposited by the bidder to this office after depositing earnest money to the Cashier of this office.
5. The material is to be lifted within 7 working days excluding the day of auction against full payment, failing which, the earnest money deposited is liable to be forfeited. The Director Farms can extend the time on the request of bidder in exceptional cases only.
6. The auction committee reserves the right to accept or reject the highest bid without assigning any reason thereof.
7. Bidder will have to arrange own container/packing material for lifting Diesel including sludge from this office. Transportation of material shall be arranged by the purchaser himself.
8. In case of any dispute, the decision of the Director of Research-Controlling Officer(Farms) will be final and binding.
9. The earnest money of unsuccessful bidders will be refunded at the end of auction. No interest will be paid on the same. However earnest money of successful bidder will be adjusted with 25% money to be deposited on the spot.
10. 25% amount of the bid accepted will have to be deposited at fall of the hammer(on spot).
11. GST and all other taxes, (if any) as per rule, will be borne by the buyer himself.
12. University employees shall not be allowed to submit quotations.
13. Other terms and conditions will be announced by the committee at the time of auction.
14. Dispute if any, shall be subject to Hisar Court of Law.
