AUCTION NOTICE

The poplar trees (30 Nos.) will be disposed off through open public auction on **06.5.2024 at 10.00 AM** in the Farm Building of the Department of Horticulture, CCSHAU, Hisar subject to the following terms and conditions:

TERMS AND CONDITIONS

1. The successful tenderer will have to deposit 25% of the amount of the highest bid within 24 hours, failing which, the tender will be cancelled and the earnest money will be forfeited.
2. The rest of the money shall be required to be deposited before starting the uprooting and cutting of trees.
3. The contractor shall have to deposit **Rs. 5,000/-** as an earnest money/security in the shape of cash/by demand draft deposit in the name of the Prof. & Head, Department of Horticulture, CCSHAU, Hisar payable at SBI, CCSHAU Branch, Hisar/any nationalized bank. **CHEQUE WILL NOT BE ACCEPTABLE.**
4. The employees of the department will not participate in the auction.
5. The trees should be lifted within one month after the auction. In case of any dispute, the decision of the committee shall be final. The roots of the trees are to be dug to at least 2 ft depth and refilled with soil.
6. If there is any loss of University property, including cutting/lifting of un-marked trees by the tenderer labour, the tenderer will be held responsible and will have to bear the loss.
7. The material will be sold "as is where is basis" and the purchaser himself will be responsible for transportation of material.
8. The contractor will not be provided any vehicle by the University for any purpose.
9. The Authorized Officers will have the right to check the work as and when they desire. The contract shall be subject to the overall superintendence, control and direction of HOD, Horticulture, CCS HAU or any other authorized officers.
10. The earnest money shall be adjusted only after completion of work and producing the 'NO DUES CERTIFICATE' from the Garden Incharge/Supervisor.
11. In case of any dispute between the parties, the same shall be referred to the arbitration of the Worthy Vice-Chancellor, CCSHAU, Hisar and his decision will be final. The provisions of Indian Arbitration Act shall apply to these proceedings.

12. The contractor will not be allowed to sub-let the contract to any other person/agency. If the sub-letting is proved, the contract shall be cancelled and security will be forfeited; the remaining work will be got done from someone else at his risk and cost.
13. It will be the personal responsibility of the contractor to adhere to all the provisions of Contract Labour (Regulation and Abolition) Act, 1970 and in case, these are not followed properly, he himself will be responsible for this. The University will not be responsible for non-observance of the said Act by the contractor.
14. The University/committee reserves the right to accept or reject the highest bid without assigning any reason thereof.
15. Non-compliance of any terms and conditions will lead to cancellation of contract.
16. All the disputed cases shall be subject to Hisar jurisdiction.
17. Other terms and conditions, if any, will be announced at the spot.

पोपलर पेड़ों की नीलामी सूचना

सर्वसाधारण को सूचित किया जाता है कि चौधरी चरण सिंह हरियाणा कृषि विश्वविद्यालय के उद्यान विभाग के अनुसंधान क्षेत्र में 30 पोपलर के पेड़ों की नीलामी दिनांक **06.5.2024** प्रातः **10.00 बजे** खुली बोली द्वारा की जाएगी। पोपलर की बोली देने वाले व्यक्ति या पार्टी को **5,000/- रुपये धरोहर राशि** के रूप में जमा कराने होंगे। बोली स्वीकृत होने पर एक चौथाई (25 प्रतिशत) राशि, बोली समाप्त होने के तुरन्त बाद जमा करानी होगी, वरना बोली रद्द कर दी जाएगी एवं धरोहर राशि जब्त कर ली जाएगी। शेष राशि पेड़ों की कटाई शुरू करने से पहले जमा करानी होगी। पेड़ों की कटाई एवं उटाई का कार्य 1 महीने में पूरा करना होगा। असफल बोलीदाता की धरोहर राशि वापिस कर दी जाएगी। इच्छुक व्यक्ति या पार्टी किसी भी कार्य दिवस में 7.00 से 2.00 बजे तक मौके पर आकर पेड़ों का बाग में निरीक्षण कर सकते हैं। कमेटी को बोली को मानने, नैगोशिएट या रद्द करने का पूरा अधिकार होगा। पोपलर के पेड़ों का विवरण एवं नीलामी की बाकि शर्तें विश्वविद्यालय की वेबसाईट **www.hau.ac.in** पर देख सकते हैं।
