This office has allocated funds amounting to Rs. 60.0 Lacs under "Loans & Advances" Scheme in the financial year 2024-25 for extending marriage loan to the University employees (Class I, II, Class III and Class IV) for self marriage and for the marriage of their wards/dependant sisters for which applications on the prescribed proforma (Copy enclosed) alongwith service book of the officials concerned complete in all respects are invited **through their respective Controlling Officers** latest by **30.06.2024**. Number of advances is restricted to two only. The marriage loan will be provided/sanctioned to the University employees for the applications complete in all respects on First-cum-First Serve basis. Other terms and conditions regarding grant of marriage loan as circulated vide this office Endst. No. CAUH/05/7035-7184 dated 19.06.2005 and No. 12059-12208 dated 26.11.2005 and as amended from time to time will remain unchanged.

- (2) It will be the responsibility of the concerned HOD/Office to bring this circular to the notice of all concerned employees and keep record of bringing these instructions to their notice in proper custody.
- (3) In case of dependent sister's marriage advance, the employee will furnish an affidavit to his/her respective office on non-judicial stamp paper of Rs. 10/- to the effect that:
 - (i) "That my parents are not alive. I am the eldest living son and the sister, loan for whose marriage is being obtained, is wholly dependent upon me."

OR

(ii) "That I am the eldest son of my family and the sister for whose marriage advance is being obtained is wholly and solely dependent upon me and financial condition of the parents is such that they cannot perform marriage by themselves."

The names of all other brothers and sisters of the University/Government employee alongwith their respective departments should also be mentioned in affidavit and they will not claim marriage advance from their departments for the marriage of their sister.
