 Earnest money must accompany each tender in the shape of Cheque/cash/draft in F/o Sr. Coordinator of any schedule bank at Hisar and each tender is to be sent in a sealed cover super scribed:-"Tender for Job work of Farm operation". Tenders not accompanied with earnest money in the shape as described above of any schedule bank shall not be considered. In case of non-acceptance of the tenders, the amount shall be refunded to them on the same day.

 The contractor shall be required to sign the contract agreement on the bond paper of Rs.20/- on the prescribed form within 10 days of the intimation of the acceptance of tender to him. Failure on his part to do so may result in invalidation of the contract and forfeiture of the earnest money.

The contractor will have to execute the job within the given time and no request for extension or time shall be entertained except in unforeseen circumstances.

In case of any loss due to negligence of contractual workers, the contractor shall be responsible to make good loss to the, failing which the amount of loss shall be recovered/adjusted from earnest money. Contractor will be liable to pay an appropriate fine as assessed if work is not completed/delayed. It will be whole responsibility of the contractor to compensate the labour on account of injury, loss of life or limb in accordance with the law in force for the time being. The University will in no way be responsible for such loss. The contractor shall be required to provide small agricultural implements (hand tools) i.e.kassi, kasola and drati etc. he will have to work as per the instructions given by the Farm In-charge. Scientist concerned/ TA (Farm) at the site. Contractor will maintain daily labour record and provide the services as per requirement. No payment will be made without daily record signed by TA farm area in-charge and Coordinator.

 In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and contractor blacklisted. The remaining job shall be got done at the risk and cost of the contractor who has defaulted.
