1. Current status of the existing biogas plant with accessories and estimation (approx. in Rs.) of the project for complete commissioning and smooth operation of the biogas plant.
2. Monitoring the proper functioning of all the accessories/instruments/machineries installed in/outside the biogas plant and submit detailed project report.
3. Any other requirements related to complete commissioning and smooth operation of the biogas plant.
4. Fully operation along with maintenance of the complete biogas plant to be provided by interested agencies/companies/ Service Providers.
5. Training to the university staff to operate and maintain the biogas plant.





INSTRUCTIONS TO BIDDERS & GENERAL CONDITIONS

1. Goals/Purpose of this expression of interest (EOI):

The objective of the EOI is the Commissioning of the Project: Designing, Engineering, Supply, Construction and Commissioning of Agri-Farm waste based Biogas plant along with biogas based Electrical Power Generation Plant (100kW electrical output) including all Mechanical, Electrical, Civil, Structural, Architectural, Control & Instrumentation Works etc. for Supply of Electricity university campus, CCSHAU, Hisar and detailed project report along with estimated cost (approx. in INR) of the project for complete commissioning and thereafter smooth operation of the biogas plant.

2. Background of the project:

The project indented to design, engineer, supply Construction and Commissioning of Agri-Farm waste-based Biogas plant along with biogas based Electrical Power Generation Plant (100kW electrical output) including all Mechanical, Electrical, Civil, Structural, Architectural, Control & Instrumentation Works etc.

- ii) The bidder/agency must have completed at least two numbers of similar projects with minimum capacity of more than 200 cubic meter biogas plant. The bidder has to submit completion/occupancy certificate for such type of project.
- iii) The minimum annual turnover of Bidder/agency should be Rs. 30.0 lakh per annum during five years duly audited by chartered accountant should be submitted.
- iv) The Bidder/agency must submit a Bar Chart with schedule of works for compliance of the work.
- v) The Bidder/agency is bound to complete the project as per the plan and design approved by the university.
- vi) For selection process of the successful Bidder/agency, the University will take the final decision.

7. Validity of the Application

The Application shall remain valid for a period of not less than 180 days after the application due date. 8. Language:

The application with all accompanying documents (the "documents") and all communication in relation to or concerning the selection process shall be in English or Hindi language and strictly on the forms provided in this EOI document. Supporting document or printed literature shall be submitted with the application and in case any of these documents is in another language, it must be accompanied by an accurate translation of all the relevant passages in either Hindi or English, in which case, for all purposes of interpretation of the application, the translation in Hindi or English shall prevail.

9. Brief Description of the selection process

This is an expression of interest and not an invitation to bid. Short-listing of the bidder/agency shall be made based on the details submitted. To complete the project Party/s should be financially sound and capable to invest on the project. The University may ask for financial documents and same has to be submitted for verification. 
