



**Terms and conditions:**

1. The appointment is only for the specified time period. The term of the appointment in one time will be for one year or termination of the project, whichever is earlier. However, in case, the work and conduct is not found satisfactory, the services can be terminated any time after giving due opportunity. If the selected candidate(s) wants to leave, he/she can do so after giving a one month notice or one-month emoluments in lieu thereof to the University. The maximum duration of engagement of YP-II is three years (1+1+1)/duration of the project, whichever is earlier.
2. The services of the employee will also be liable to be terminated at any point of time, without assigning any reason because of non-release of the funds by the Funding agency under whose project/scheme the job is advertised.
3. On expiry completion of the project/term of the project, he/she will stand relieved and the university/department will not be responsible/liable for his/her adjustment in the university.
4. He/she will not be a regular employee of the University and would not be entitled to any CPF/GPF or other benefits admissible to the regular employee.
5. He/she will be required to produce a medical certificate of fitness from the CMO of the University at the time of joining.

6. He/she should report for duty within 15 days of issue of order of appointment, failing which his/her appointment will be treated as cancelled and may be offered to any other selected candidate.
7. His/Her place of work will be at Department of Agril. Meteorology, CCSHAU, Hisar.
8. He/she will be required to execute an agreement on a Non judicial Stamped paper of Rs. 15/- before he/she is allowed to join the post.
9. TA/DA will be payable equivalent to the entitlement of Grade-IV employees as mentioned in CCS HAU TA Rules of the University. However, no TA/DA will be payable for appearing in the interview.
10. Ph.D. students have to produce NOC from the Dean PGS at the time of interview.
11. YP-II will be under the administrative control of project PI and will be entitled for leave as per university guidelines/norms.
12. The engagement of YP-II in the project will be full time and will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.
13. The university may modify, add, delete and/or amend/change the rules with the approval of the Vice-Chancellor, CCS HAU Hisar.

The interview will be held on **23-01-2025 at 10.00 AM** in the office of Director of Research CCS HAU, Hisar. No, separate letter for interview will be issued. No TA/DA will be paid for attending the interview. Original Certificates will be required to produce/shown at the time of interview (please also bring certified true copies or original certificates to be submitted to the University).


