**Subject: Call for quotations for Agri Drone pilot services for demonstration of spray of nano fertilizers and pesticides in wheat, mustard, chickpea, fruit, vegetable crops along with all necessary assistants (in terms of handling, transportation and back-up facilities for drone etc.)**

The CCSHAU Krishi Vigyan Kendra-Hisar is inviting sealed quotations from approved agencies/govt agency/trained pilot having the DGCA approved facilities for the work of spraying of nano fertilizers, micro nutrients and agro chemicals in total 102 hectare area of wheat, mustard, chickpea, fruits and vegetable crops etc through our office/other institute drone. The interested firms/trained drone pilot can get tender form from the office of Krishi Vigyan Kendra, Sadalpur (Hisar) by paying Rs. 150/- from 18.01.2025 to 28.01.2025 between 9.00 am to 4.30 pm on working day (form also attached below). The quotation should be reach to the undersigned latest by 29.01.2024 before 4.30 am positively through speed post/courior to undersinged. The sealed quotation without earnest money shall be rejected. These quotations will be opened on 31.01.2025 (1.00 pm) at CCSHAU Gandhi Bhawan by committee constituted for this purpose. Quotations are invited to the office of undersigned in the light of condition given below:

1. Applicant/firm have valid drone pilot license. Pilot will follow the all guidelines of GOI for drone uses.
2. Estimated cost of work will be Rs. 99450/- (approximate) and earnest money will be Rs 2000/- (cash/draft).
3. The sealed quotation shall be opened by the committee at Gandhi Bhawan, CCSHAU Hisar in the presence of renderers' /Rep. who would like to be present at that time. Due to unavoidable circumstances, the date, time and venue for the opening of the sealed quotation may be changed with a notice to this effect on university website.
4. In case forms are downloaded from the official website of CCS HAU Hisar, duly filled sealed quotation form should be accompanied by a Cash/Demand Draft of Rs.2000/- in favor of Sr. Coordinator KVK Hisar.
5. The rates of work should be quoted on one hectare basis including GST/Tax and all transportaion expenses etc. The firm/agencies/pilot will maintain all required records of demonstration conducted and submit to this office.
6. Administrative approval to execute the above listed work has been obtained from the competent authority.
7. The firm/agencies will provide the trained pilot for spray in fields along with all necessary assistants (in terms of handling, transportation and back-up facilities for drone etc.). The firm providing additional facility to complete the targeted area should be given priority. The boarding and lodging facility for the drone pilot and his team shall be borne by concerned firm/agency.
8. The fertilizes/chemicals/nano-fertilizers/micro nutrients and drone will be provided by CCSHAU Krishi Vigyan Kendra, Sadalpur (Hisar). KVK will bear the expenditure of all kind of fertilizers/chemicals/nano-fertilizers and drone only. No other expenditure will be borne by KVK Hisar.
9. Work should be completed before 10<sup>th</sup> March 2025.
10. Any damage, maintenance, to and fro expenses of the drone and his team or any other similar liability of any kind shall be of the concerned firm/agencies. The travelling allowances and residential expenses during the stay will be bear by the pilot/firm/owners. KVK will not responsible for any damage due to drone or mishandling. Drone pilot will be held responsible for any mishappening due to drone.
11. The quantity of work given above is tentative and may change depending upon the actual field situation. The area of demonstration to be conducted by drone may be at various locations in district Hisar.
12. The committee shall have the right to open negotiations with the lowest bidder. The committee further reserves the right to accept or reject the lowest tender without assigning any reason.
13. The bid will be allotted to the firm whose quotation will be found lowest. The decision of committee will be final.
14. The work will have to be done on bill basis and payment will be made within 15 days after completion of work.
15. Representiove of person/firms may join the opening of quotations, if they wish.
16. Any change in date of submite requir/mill communicate telephonical to the undersigned committee
