





Subject: Value assessment & auction of Guava, Citrus, Ber and Sahtoot and other fruits crops orchard at KVK Hisar (VPO: Sadalpur) farm for FY 2025-26

The Committee constituted by Director of Extension Education CCS HAU inspected the orchard on 13.05.2025 at KVK Hisar (VPO: Sadalpur) farm and assessed the various fruit orchard with following terms and conditions:

1. Auction notice should be uploaded on HAU website for open auction of Guava, Citrus, Ber and Sahtoot and other fruits crops.
2. Tender form (costing Rs. 100/-) may be obtained from the office of the Coordinator, CCS HAU KVK, Sadalpur (Hisar) on cash payment.
3. Auction will be applicable for the period up to 30.04.2026.
4. The material will be sold "as is where basis is" and the transportation will be made by the purchaser himself.
5. The auction committee reserves the right to accept or reject the highest bid without assigning any reason thereof.
6. The bidders will have to attach the earnest money of Rs. 15,000- (Rs. Fifteen thousand only) in the shape of Demand Draft/cash along with the tender application in favour of Coordinator, KVK Hisar.
7. Bid value will be given including all taxes. 25% of the bid value will have to be deposited by highest bidder within 24 hours of office order and the remaining amount will have to be paid ~~within~~ in three installments dated on 30 Sept., 2025, 31 Oct., 2025 and 30 Nov., 2025, failing which the earnest money will be forfeited.
8. Tenderer have to take permission from the Coordinator, KVK Hisar/ Farm Incharge at the harvesting the fruits crop.
9. No labour will be provided to the bidder for the purpose of irrigation, harvesting, spraying etc. however facility of irrigation & input will be provided to bidder as per recommended package of practices of CCSHAU Hisar. No other chemicals allowed other than practices package of under the supervision of KVK team.
10. Krishi Vigyan Kendra Hisar and CCSHAU Hisar will not be held responsible for any kind of loss & damage due to any natural calamities and other damage/ loss.
11. The earnest money (Demand Draft or Cash) of the unsuccessful bidder will be given back in the department or sent by post after the finalization of the successful bid and no interest will be paid on the same. The security money shall be refunded only after producing the NO DUES CERTIFICATE from the Farm Area In-charge/supervisor of KVK. Security will be forfeited in case of violation of term and conditions by successful bidder Security amount will be refunded after 30.04.2026 if term and condition fulfilled.
12. In case of any loss and damage by bidder or his worker in farm/orchard and office building property the contractor/bidder will be held responsible for this and he will be liable to loss recovery.
13. In case of any dispute, the decision of the Committee shall be final.
14. Any Intercrop/short duration crop taken for improvement of orchard will be harvested/ property of KVK
