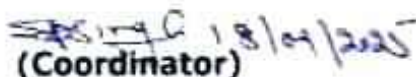

The tenders shall be opened on 19/09/2025 at 11.00 AM in the office of Senior Coordinator, KVK Panipat/ Directorate of Extension Education, CCS HAU Hisar in the presence of tenderers/Rep. who would like to be present at that time. Due to unavoidable circumstances, the date, time and venue for the opening of the tenders may be changed with a notice to this effect on university website.

12. The FCA is to work among the farmers for execution of the CRM Scheme objective. The quantity of work given above is tentative and may change depending upon the actual requirement. The contract may be extended through mutual agreement between the parties.

13. The committee shall have the right to open negotiations without assigning any reason. The committee further reserves the right to accept or reject the lowest tender without assigning any reason.

14. Only the person who himself will perform this job work will be allowed to apply for this job contract and minimum qualification set forth will be Senior Secondary/ High School pass and to have experience in farming..
