- 1. Tender form (costing ₹ 150/-+GST 18%) may be obtained from the office of the Sr. Coordinator, CCSHAU KVK, Kaithal on cash payment upto 19.3.2025. The tender form/quotations should be depostied latest by 20.09.2025 up to 10:0 am in the office of Sr. Coordinator KVK, Kaithal.
 - 2. Tender for the job on contract work will be opened in the presence of Committee at CCSHAU, KVK Kaithal. In case of holiday or in case of non avilability of committee members tender will be open next day or other working day after discussion to members and tenders of their agents who may like to present. Tenders must be sent by post(complete in all documents)in a sealed envelope by due date or be delivered in person by tenderer/ their agents to KVK, Kaithal. On the envelope tenderer's address be also given as from (with name and address of the quotee) on the
 - 3. Earnest money must accompany each tender in the shape of Cheque/cash/draft in f/o Sr. coordinator of any schedule bank at Kaithal and each tender is to be sent in a sealed cover super scribed:-"Tender for job work of farm operation".
 - 4. Tenders not accompanied with earnest money in the shape as described above shall not be considered. In case of non-acceptance of the tenders, the amount shall be refunded to them on the
 - 5. The contractor shall be required to sign the contract agreement on the bond paper of Rs. 20/- on the prescribed form within 10 days of the intimation of the acceptance of tender to him. Failure on his part to do so may result in invalidation of the contract and forfeiture of the earnest money.

 - 9. In case of any loss due to negligence of contractual workers, the contractor shall be responsible to make good loss to the failing which the amount of loss shall be recovered/adjusted from earnest money. Contractor will be liable to pay an appropriate fine as assessed if work is not
 - 10. It will be whole responsibility of the contractor to compensate the labour on account of injury, loss of life or limb in accordance with the law in fore for the time being. The University/KVK
 - 11. The contractor shall be required to provide small agricultural implements (hand tools) i.e kassi, kasola and drati etc. he will have to work as per the instruction s given by the Farm In-Charge, Scientist concerned/TA (farm) at the site. Contractor will provide the services as per
 - 12. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and contractor blacklisted. The remaining job shall be got done at the risk and cost of
 - 13. The KVK reserves the right of supervision. Transport for transporting labour will not be provided by the KVK.
 - 14. The parties may visit the site for this purpose before submitting their tenders.
 - 15. In case of any dispute between the parties the same will be referred to arbitration of the Vice-
 - 16. The instruction issued vide Registrar's Endst. No. 6653-6775 dated 4.07.2015 shall be followed.
 - 17. No other members of contractor's family should quoted rates for the work.
 - 18. The contractor should abide by the following provision strictly:
 - a) Workers are paid wages by 7th of every month by contractor.
 - b) Workers are paid the minimum wages at least as provided under the Minimum Wages Act.
 - c) Wages slips are issued regularly to workers by the contractors.
