Terms and conditions of the tender:

 Tenders will be received by the Senior Coordinator KVK Kurukshetra upto 30.09.2025 upto 10.00 AM .and will be opened by the committee in the presence of such tenders or their agents who may like to present.

2. Tenders must be submitted on a prescribed Performa obtaining from office of the undersigned and sent by post in a sealed envelope by due date or be delivered in person by the tenderers or their agents to the Senior Coordinator KVK Kurukshetra. Tenders must be scribed on envelope as "Tenders for the above said two works and address of the Senior Coordinator KVK Kurukshetra. On the envelope Tenders' address be also given as from with name and address of the quote) on the other side of the envelopes.

3. Earnest money amounting to **Rs. 1900**/- accompany each tender in the shape of Cash receipt/Draft of any schedule bank at Kurukshetra and each tender is to be sent in a sealed cover super scribed "Tender for the above said work of Scheme and address to the Senior Coordinator KVK Kurukshetra.

4. Tenders <u>not accompanied</u> with earnest money in shape of deposited Cash receipt / Draft any schedule bank at and the amount of earnest money pledged to the Senior Coordinator KVK Kurukshetra shall not be considered. In case of non acceptance of the tenders, the amount shall be refunded to them on the same day.

5. If a contractor employs more than 20 labour per day in a particular contract, then obtaining Licence by the contractor and getting registration by the University from the Labour Deptt. is necessary. This is to be completed in respect of each contractor work. The needful is required to be got done within 15 days from the date of start of work by contractor.

6. If the number of labour employed in particular contract is less than 20, the Licence / registration as at Sr.No.5 above is not entertained by the labour Deptt.

7. Conditional tenders are liable to be rejected.

8. The contractor shall be required to sign the contract agreement on the bond paper or Rs.20/- on the prescribed form within 10 days of the intimation of the acceptance of tender to him. Failure on his part to do so may result in invalidation of the contract and for failure of the earnest money.

9. Income tax @ 2.20% to be deducted from the bill(s) at source.

- 10. The contractor will have to execute the job within the given time and no request for extension or time shall be entertained except in unforeseen circumstances.
- 11. Payment will be made after the completion of job satisfactory on monthly basis.
- 12. The contractor shall be responsible for observation of the provision of the contract labour (Regulation and Abolition) Act 1970. The University shall not be responsible for it in any
- 13. In case of any loss due to negligence of contractual workers the contractor shall be responsible to make good loss to the Senior Coordinator KVK Kurukshetra, failing which the amount of loss shall be recovered adjusted from earnest money.
- 14. It will be sole responsibility of the contractor to compensate the labour on account of injury, loss of life or limp in accordance with the law in force for the time being. The University will no way be responsible for such loss.
- 15. It will also be the responsibility and liability of the contractor to adhere to the provisions of the ESI and provide Fund Act and in case they are not followed properly he himself be responsible for it.
- 16. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and the contractor black listed. The remaining job shall be got done at the risk and cost of the contractor who has defaulted.
- 17. The University reserves the right of supervision. Transport for transporting labour will not be provided by the University.
- 18. The parties may visit the site and contact the Senior Coordinator KVK Kurukshetrafor the purpose before submitting their tenders.
- 19. In case of any dispute between the parties the same will be referred to arbitration of the Vice Chancellor and his decision shall be final. The provision of Indian Arbitration Act shall apply to these proceedings.

20. Only registered contractor is eligible for filling the tender.
