NOTICE FOR INVITING TENDERS FOR EXECUTION OF THE CONTRACTUAL FARM AND RELATED JOB WORKS.

1. Name and address of the Department: CCS HAU, Krishi Vigyan Kendra, Jagdishpur, Sonipat
2. Job description and other related activities/operation in details: Different Farm and related job works at CCS HAU, Krishi Vigyan Kendra, Jagdishpur, Sonipat.
3. Duration of the contract: October, 2025 to March, 2026
4. Estimated cost: Rs. 290000=00(Inclusive of all applicable taxes)
5. Earnest Money Rs. 5800=00 (2% of the estimated cost)
6. Date of opening order: 15th October 2025, 11:00 A.M.
7. Cost of Tender From Rs. 100/- (18% GST extra)

Terms and conditions of the tender:

1. Tender forms for filing the tenders can be obtained from the office of the Krishi Vigyan Kendra, Jagdishpur, Sonipat on any working day during working hours (9.30 AM to 4.00 PM) from 08th October 2025 to 14th October 2025 (up to 4:00 P.M.) and may also be downloaded from the official website of CCS HAU, Hisar (<http://hau.ac.in>).
2. Duly filled tenders will be received in this office of SENIOR COORDINATOR, Krishi Vigyan Kendra, Jagdishpur, Sonipat on 14.10.2025 by 04.30 P.M. and will be opened on 15-10-2025 at 11.00 A.M. in the office of Senior Coordinator KVK, Sonipat/ directorate of Extension Education, CCS HAU, Hisar in the presence of such tenderes or their agents who may like to present.
3. Due to unavoidable circumstances, the date, time and venue for the opening of the tenders may be changed with a notice to this effect on university website.
4. Administrative approval to execute these farm works has already been obtained from the competent authority.
5. Tender must be in a sealed cover and it must be scribed on the envelope as "Tenders for the Farm and Related job works and addressed to the SENIOR COORDINATOR. KVK, JAGDISHPUR, SONIPAT. The tenders address should also be mentioned on the envelope.
6. Earnest money amounting to Rs. 5800=00 must accompany each tender in the shape of Cross Cheque/draft of any schedule bank in-favour of Senior Coordinator payable at Sonipat. Tenders not accompanied with earnest money will be rejected. In case of non-acceptance of the tenders, the amount shall be refunded to tenderer.
7. Conditional tenders are liable to be rejected. The vague and unrealistic tenders shall also be rejected. The tenders unreasonably below the estimate costing doubt on its actual execution may also be rejected.
8. The contractor should have legal capacity to apply for this tender and he may give details of his experience in the execution of same or similar works at research/government farms.
9. The contractor shall be required to sign the contract agreement within 10 days of the intimation of the acceptance of tender to him. Failure on his part to do so may result in invalidation of the contract and forfeit of the earnest money.
10. Income tax @2% will be deducted from the bill(s) at source.
11. The contractor will have to execute the job within the given time and no request for extension of time shall be entertained except in unforeseen circumstances and in the interest of the university.
12. Payment will be made after completion of the job satisfactorily or on monthly basis.
13. In case of any loss due to negligence of contractual workers, the contractor shall be responsible to make full loss to University and the same may be deducted from the earnest money or running bills.
14. It will be the sole responsibility of the contractor to compensate the labour on account of injury, loss of life or

limb in accordance with the law in force for the time being. The University will in non way be responsible for such loss.

15. The contractor shall be required to provide small agricultural implements (hand tools) i.e. Kassi, Kasola and drati etc., he will have to work as per the instruction given by the designated officer/employee of the University for that purpose.
16. It will also be the responsibility and liability of the contractor to adhere to the provisions of all applicable laws in the said tender; and in case these are not followed properly, he/she himself/ herself will be responsible for it.
17. In case of breach of terms and conditions of the contract or any of them, the contract shall be cancelled and contractor will be black listed. The remaining job shall be got done at the risk and cost of the contractor who has defaulted.
18. The University reserves the right of supervision. Transport for transporting labour will not be provided by the University.
19. The parties may visit the site of work and may contact in the office of CCS HAU Krishi Vigyan Kendra, Jagdishpur, Sonipat for this propose before submitting their tenders. They may seek necessary guidance and help in filling the tender but in no way breaching the confidentiality of tender.
20. The contractor should certify in tender that no other member of his family has applied tender for the same work.
21. In case of any dispute between the parties, the same will be referred to Worthy Vice-Chancellor for arbitration and his decision shall be final. The provision of Indian arbitration Act shall apply to these proceedings.
22. The quantity of work given above is tentative and may change depending upon the actual filed situation. The contract may be extended through mutual agreement between the parties.
23. The committee shall have the right to open negotiations without assigning any reason. The committee further reserves the right to accept or reject the lowest tender without assigning and reason.
24. The rates and amount for each job work included in the tender should be quoted in clear terms and incomplete tender in any respect may be rejected.
