Terms and conditions of the tender

- 1. Duly filled tenders will be received in the office of REGIONAL RESEARCH STATION (HORTICULTURE), BURIA (YAMUNANAGAR) up to 06.11.2025 by 4.00 PM and will be opened on 07.11.2025 at 2.30 PM in the presence of such tenderers or their agents who may like to present.
- 2. Administrative approval and financial sanction to execute these field works has been obtained from the Competent Authority.
- 3. Tender must be in a sealed cover and it must be scribed on the envelope as "Tenders for the field work (Field work at RRS, Buria, Yamunanagar)" and addressed to the REGIONAL INCHARGE, (HORTICULTURE), BURIA (YAMUNANAGAR). The tenderer's address should also be mentioned on the envelope.
- 4. Earnest money amounting to Rs. 1000/- must accompany each tender in the shape of cash deposit/National Plan Certificate/deposited at call receipt/draft/of any scheduled bank in favour of Principal Scientist In-Charge, RRS (Horticulture), Buria payable at Buria. Tenders not accompanied with earnest money will be rejected. In case of nonacceptance of the tenders, the amount shall be refunded to the tenderer.
- Conditional tenders are liable to be rejected.
- 6. The contractor shall be required to sign the contract agreement on the bond paper of 100/- on the prescribed form within 10 days of the intimation of the acceptance of tender to him. Failure on his part to do may result in invalidation of the contract and forfeiture of the earnest money.
- Income tax @ 2% will be deducted from the bill(s) at source.
- 8. The contract will have to execute the job within the given time, and no request for extension of time shall be entertained except in unforeseen circumstances and the interest of the university.
- 9. Payment will be made after completion of the job satisfactorily.

- 10. The contractor shall be responsible for the observance of the provisions of all applicable laws in the said tenders. The University shall not be responsible for it in any manner.
- 11. In case of any loss due to negligence of contractual workers, the contractor shall be responsible to make full loss to the University, and the same may be deducted from the earnest money or running bills.
- 12. It will be the sole responsibility of the contractor to compensate the labour on account of injury, loss of life or limb by the law in force for the time being. The University will in no way be responsible for such loss.
- 13. The contractor shall be required to provide agricultural implements, i.e., Kassi, Kasola, Darati,Tractor along with diesel etc., he will have to work as per the instructions given by the designated officer/employee of the University for that purpose.
- 14. It will also be the responsibility and liability of the contractor to adhere to the provisions of all applicable laws in the said tender, and in case they are not followed properly, he/she himself/herself will be responsible for it.
- 15. In case of breach of the terms and conditions of the contract or any of them, the contract shall be cancelled, and the contractor will be blacklisted. The remaining job shall be completed at the risk and cost of the contractor who has defaulted.
- 16. The University reserves the right of supervision. Transport for transporting labour will not be provided by the University.
- 17. The contractor must issue an attendance card to each workman employed by him in connection with field work. The record pertaining to the attendance of workmen can be examined at any time.
- 18. The parties may visit the site of work and may conduct in the office of CCS HAU REGIONAL RESEARCH STATION (HORTICULTURE), BURIA (YAMUNANAGAR) for this purpose before submitting their tenders. They may seek necessary guidance and help in filling the tender but in no way breaching the confidentiality of tender.
- 19. The contractor should certify in the tender that no other member of his family has applied for the same work.
- 20. In case of any dispute between the parties, the same will be referred to the Worthy Vice-Chancellor for arbitration, and his decision shall be final. The provisions of the Indian Arbitration Act shall apply to these proceedings.
- 21. If the bidder/contractor has no GST No., he/she has to give the undertaking "I have no GST Number and my annual profit/cash flow is not above Rs. 20 lacs."
- 22. The quantity of work given above is tentative and may change depending upon the actual field situation. The contract may be extended through mutual agreement between the parties.

23. The committee shall have the right to open negotiations without assigning any reason. The committee further reserves the right to accept or reject the lowest tender without assigning any reason.
