

It is for the general information to the public that open auction will be scheduled on 05.03.2026 (Monday) at 10:00 A.M. for dispose-off of 210 trees in which 8 trees of Teak (Standing dry/fallen), 23 trees of Salix (Standing dry), 23 trees of Kadam(Standing dry), 39 trees of Shisham (Standing dry/fallen), 21 trees of Khejri (Standing dry/fallen), 37 trees of Neem (Standing dry/fallen), 1 tree of Moringa (Fallen), 1 tree of Babool (Fallen), 3 trees of Casuarina (Fallen), 54 trees of Safeda (Standing dry/fallen) by cutting, digging /uprooting, lifting and removing from the sites. The Auction process will be carried out at Forestry Research Farm, Department of Forestry, CCSHAU, Hisar. If the auction is not done on the said date due to unavoidable reasons, the same shall be done on the next working day at 10:00 A.M.

Terms and Conditions

1. The contractors/bidders will be required to deposit security money of Rs. 10,000/- (in Cash) prior taking part in the open auction. The security money i.e. Rs. 10,000/- of the highest bidder will be kept with this department in form security, which will be returned upon successful completion of the assigned work as per terms and conditions of the auction.
2. The highest bid will be accepted subject to the approval of the auction committee.
3. Twenty-five percent (25%) of the bid value shall be deposited by the highest bidder immediately after completion of the bidding process. The remaining seventy-five percent (75%) amount shall be deposited within three (3) days of receipt of the official order. Failing this, the earnest money shall be forfeited and the tender/auction shall stand cancelled.
4. The auction committee reserves the right to accept or reject any bid/highest bid without assigning any reason thereof. In case, any dispute arises, the committee decision will be final.
5. The successful bidder shall be solely and fully responsible for any injury, accident, or loss of life occurring during the cutting, lifting, handling, transportation etc. of the auctioned trees/material. The Department/University shall not be held responsible or liable for any loss or damage to persons, property, machinery, or material arising out of or during the execution of the auction work, by any cause whatsoever. No damage shall be caused to nearby standing trees, experimental plots, infrastructure, or government property during harvesting operations. Any damage caused shall be recovered from the bidder.
6. Upon completion of the auction, the department will not be held responsible for any type of loss in material auctioned by any means.
7. The purchaser/bidder will have to lift the auctioned material with in a period 15 days excluding the day of auction against full payment. If the trees material will not be lifted within the stipulated period, then the material would be re-auctioned and responsibility will rest upon the purchaser/bidder. No request for extension of time shall be entertained except in unforeseen circumstances by the Prof. & Head Department of Forestry, CCSHAU, Hisar.
8. The party/purchaser have to harvest the trees roots up to 3 feet depth with refilling the same with soil.
9. GST @ 18 % in addition will be paid by the purchaser/bidder. All other type of taxes, fees etc. on the auctioned material, if any, will be borne by the purchaser/bidder himself.
10. The above material will be F.O.R. "AS IS WHERE IS BASIS" and no claim regarding quantity, quality, or volume etc. shall be entertained after the auction. Cutting, extraction, transportation etc. of the trees shall be the responsibility of the successful bidder, at his own cost and risk.

11. The material at the sites can be inspected by the interested party/parties during any working day of University from 10:00 A.M. to 04:30 P.M.
12. The work executed by the successfully bidder will be inspected by the committee members, upon satisfaction of the committee, thereafter security money i.e. Rs. 10,000/- will be refunded to the bidder.
13. In case of denial by the highest purchaser/bidder, the security money of the highest will be forfeited.
14. The successful highest purchaser/bidder shall comply with all forest, environmental, labor, and transportation laws, rules, and regulations applicable at the time of harvesting and removal of trees.
15. The trees are being auctioned primarily for research purposes, and the highest bidder/ purchaser shall cooperate with the Department in data recording, sampling, and related research activities.
16. The successful highest purchaser/ bidder shall provide the required wood samples, discs, logs, or other material free of cost to the Department for research and academic purposes, as required by the Department.
17. The employees of the University cannot participate in the auction process.
18. Other terms & condition, if any, will be announced by the committee on the spot at the time of auction.
19. In case of any dispute, the Worthy Vice-Chancellor, CCSHAU, Hisar will be act as Arbitrator and his decision shall be final. The provisions of Indian Arbitration Act shall also apply to these proceedings.
20. All the disputed cases shall be subject to Hisar jurisdiction only.
21. These terms and conditions shall be binding on all participants, and participation in the auction shall be deemed as acceptance of the same.
