2. Details of Work:-

Sr. No.	Name of Operations
1.	Harvesting of wheat by combine harvester in 18 acres
2.	Transplanting of paddy in 18 acres
3.	Manual weeding in paddy in 17 acres
4.	Sprays of insecticides/weedicides/ fungicides/ foliar application of fertilizers in paddy in 18 acres (5 sprays in 18 acres)
5.	Other works like paddy nursery raising, broadcasting of fertilizers (urea, DAP, zinc sulphate & murate of potash) in 18 acres, cleaning of grasses from boundary, repairing of bunds and irrigation channels, irrigation in 18 acres including pre-sowing/puddling irrigation, gardening work of KVK campus lawns (planting, hoeing/weeding, watering, cutting, cleaning etc) and maintenance work in KVK demo unit (on need basis for the period of 01.04.2026 to 30.09.2026).
6.	Labour work like preparation of sowing beds, sowing/planting, watering, weeding, thinning, preparation & application of natural farming formulations etc in one acre area of natural farming demo unit of KVK (on need basis for the period of 01.04.2026-30.09.2026).
