The Personnel Committee/Board of Management vide item No. B-9/A-7 in their 97th / 280th meeting held on 10.04.2026 has approved the following:

Selection Criteria for direct recruitment:

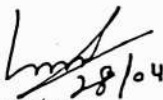
1. **Assistant Professor/equivalent posts:**
The selection criteria for the post of Assistant Professor/equivalent (Annexure-III).
2. **Associate Professor/equivalent & Professor/equivalent posts:**
The existing criteria circulated vide Memo No. Admn.R2/17/TM-82/126-250 dated 02.01.2018 may be continued.
3. **Senior Professor/equivalent posts:**
The existing criteria for the post of Professor/equivalent circulated vide Memo No. Admn.R2/17/TM-82/126-250 dated 02.01.2018 may be followed.

Other guidelines relating to direct recruitment:

1. **Equivalency:**
 - i) the word "teaching" and "research" may be replaced as "teaching/research/extension" in the revised minimum qualifications and measure for the maintenance of standards in higher education, 2022 based on University Grant Commission Regulations, 2018.
 - ii) The word "Assistant Professor", "Associate Professor" and "Professor" may be replaced as "Assistant Professor/equiv.", "Associate Professor/equiv." and "Professor/equiv." in the revised minimum qualifications and measure for the maintenance of standards in higher education, 2022 based on University Grant Commission Regulations, 2018.
2. The UGC guidelines and amendment regarding qualifications from time to time circulated by State Govt. are recommended to be followed along with guidelines of Other Agencies where applicable.

3. The Eligibility for direct recruitment may be same as per the revised minimum qualifications and measure for the maintenance of standards in higher education, 2022 based on University Grant Commission Regulations, 2018.
4. The Academic Council may be authorized to specify the concerned/relevant/allied subject of Masters and Ph.D Degree.
5. The shortlisting of candidates for the post of Assistant Professor/equiv. may be same as per UGC Guidelines. However, the research publication of ICAR listed Journals may also be considered for marks in the shortlisting criteria. In Research Publications and Award 2 marks each may be given for 1st and corresponding author thereafter one mark for others. If the period of teaching/post-doctoral experience is less than one year than the marks shall be reduced proportionately to the extent i.e. 0.5 marks for each completed 3 months.
6. All the eligible candidates for the posts of Associate Professor/equiv., Professor/equiv. and Senior Professor may be called for interview.
7. The existing criteria (for shortlisting of candidates for interview to the post of Assistant Professor/equivalent) may be followed i.e. the University will shortlist 15 eligible candidates against one post and further an addition of five more eligible candidates (i.e. 15+5=20) against each post and so on, as per merit list on the basis of structural marking. Only shortlisted candidates will be called for interview. The condition of shortlisting will also be applicable to the reserved posts. If the number of candidates are more than one having same marks than the seniority for shortlisting will be decided on the basis of marks obtained in Postgraduate degree, if still the marks are the same than the seniority in age will be senior in merit.
8. The Academic Council with the approval of BOM may lay down criteria and procedure for selection of faculty member (Professor/equiv.) who are from outside the academic field and for the post involving different nature of responsibilities in certain discipline/area of existing/newly created posts.

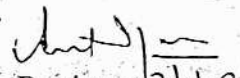
