Terms and conditions:

1. Initially the appointment will be for one financial year i.e. upto 31-03-2027. However, in case, the work and conduct are not found satisfactory, the services can be terminated any time after giving due opportunity of being heard to concerned employee. If the selected candidates (s) wants to leave. He/she can do so after giving a one month notice in writing to the University.
2. The appointment is co-terminus with the project. The initial engagement of YPs will be for one year, which is extendable for 2 more years (One year at a time) subject to requirement of services in the project and satisfactory performance of candidates after evaluation by PI/HOD and final approval by Director of Research or duration of the project, whichever is earlier.
3. On expiry completion of the project/term of the project, he/she will stand relieved and the university/department will not be responsible/liable for his/her adjustment in the university on any other post (it is made clear that there is no equivalent post in this university in the same identical project/scheme).
4. He/she will not be treated as a regular employee of the University and would not be entitled to any CPF/GPF or other benefits admissible to the regular employee.
5. The services of the employee will also be liable to be terminated at any point of time, without assigning any reason because of non-release of the funds by the Funding agency under whose project/scheme the job is advertised.
6. TA/DA will be payable as per rules of the University. However, no TA/DA will be payable for appearing in the interview.
7. He/she will be required to produce a medical certificate of fitness from the CMO of the University at the time of joining.
8. He/she should report for duty within 15 days of issue of order of appointment, failing which his/her appointment will be treated as cancelled and may be offered to any other selected candidate.
9. He/she will be required to execute an agreement on a Non-judicial Stamped paper of Rs. 15/- before he/she is allowed to join the post of Young Professional-II.
10. Ph.D. students have to produce NOC from Dean, PGS at the time of interview.
11. YP's will be under administrative control of PI
12. YP's will be entitled for leave as per university norms.
13. YP engagement will be full time. They will not be allowed to do their work or to accept or whole another appointment with or without remuneration elsewhere.
