5. The candidate will not be a regular employee and will not be entitled to CPF/GPF or any other benefits admissible to regular employees.
6. A medical fitness certificate from the CMO of CCS HAU will be required at the time of joining.
7. The candidate must report for duty within 10 days from the date of issue of the appointment order, failing which the appointment will be treated as withdrawn.
