ORDER

Due to prevailing situation of COVID-19 in the State, the Chief Secretary-cum-Chairperson, Haryana State Executive Committee, Haryana State Disaster Management Authority, Govt. of Haryana vide No. DMC-SPO-2020/1028 dated 28.01.2022 has issued instructions to be followed in the State.

In view of above, the competent authority has approved the following instructions for meticulous compliance in the University Campus and at outstations as well w.e.f. 01.02.2022-

- i) The University may be opened for teaching research and extension purpose with full strength by adopting requisite social distancing norms/ regular sanitisation and Covid-19 appropriate behaviour.
- ii) All the Deans/Principal COA, Kaul, Bawal and Campus school may advise all the students of age group more than 15 years to have at least first dose of vaccination, while attending physical classes.
- iii) The restrictions from the opening of Library for limited period as well as other restrictions may be lifted, however, the Covid-19 appropriate behaviour is to be followed.
- iv) All the offices may function in routine. However, the Officer Incharge must ensure social distancing norms/ regular sanitisation and Covid-19 appropriate behaviour and in case any additional space is required to maintain social distancing, the Controlling Officer concerned may provide/allow the space accordingly.
- v) The persons with disabilities and Pregnant women employees shall be exempted from attending office but are required to work from home.
- vi) The quarantine leave as applicable may be provided to the employee affected from virus and report in this regard may be submitted to the Registrar Office as per past practice.
- vii) Campus School may also be opened for the class 10th to 12th with the conditions as mentioned in the letter of Chief Secretary dated 28.01.2022 and for the rest of the students online classes may be continued.
- viii) The Committees already constituted to ensure the Covid-19 appropriate behaviour may function as such till further order.

All other instructions/SoPs/guidelines shall remain in force and the above instructions shall be operative till further orders.
