## **DISTRICT ADMINISTRATION, HISAR**

## ORDER

Whereas, the COVID-19(Omicron variant) pandemic is again posing threat to public health. District Administration has considered it necessary to take effective measures to prevent its spread in district Hisar. In compliance of order issued by the Haryana State Disaster Management Authority, Haryana. Chandigarh vide memo No. DMC-SPO-2020/5215, dated 02-05-2021, it was declared a lockdown from 03-05-2021 (05:00 AM onwards) to 10-05-2021 (till 05:00 AM) in District Hisar vide order No. 2008-2088/MA dated 03-05-2021, same was extended as Mahamari Alert-Surakshit Haryana (महामारी अलर्ट-सुरक्षित हरियाणा) from 10-05-2021 (05:00 AM onwards) to 17-05-2021 (till 05:00 AM), 17-05-2021 (05:00 AM onwards) to 24-05-2021 (till 05:00 AM), 24-05-2021 (05:00 AM onwards) to 31-05-2021 (till 05:00 AM), 31-05-2021 (05:00 AM onwards) to 07-06-2021 (till 05:00 AM), 07-06-2021 (05:00 AM onwards) to 14-06-2021 (till 05:00 AM), 14-06-2021 (05:00 AM) to 21-06-2021 (till 05:00 AM), 21-06-2021 (05:00 AM) to 28-06-2021 (till 05:00 AM), 28-06-2021 (05:00 AM) to 05-07-2021 (till 05:00 AM), 05-07-2021 (05:00 AM) to 12-07-2021 (till 05:00 AM), 12-07-2021 (05:00 AM) to 19-07-2021 (till 05:00 AM), 19-07-2021 (05:00 AM) to 26-07-2021 (till 05:00 AM), 26-07-2021 (05:00 AM) to 02-08-2021 (till 05:00 AM), 02-08-2021 (05:00 AM) to 09-08-2021 (till 05:00 AM), 09-08-2021 (05:00 AM) to 23-08-2021 (till 05:00 AM), 23-08-2021 (05:00 AM) to 06-09-2021 (till 05:00 AM), 06-09-2021 (05:00 AM) to 20-09-2021 (till 05:00 AM), 20-09-2021 (05:00 AM) to 04-10-2021 (till 05:00 AM), 04-10-2021 (05:00 AM) to 18-10-2021 (till 05:00 AM), 18-10-2021 (05:00 AM) to 14-11-2021 (till 05:00 AM), 14-11-2021 (05:00 AM) to 28-11-2021 (till 05:00 AM) and further from 28-11-2021 (05:00 AM onwards) to 31-12-2021 (till 05:00 AM) along with guidelines to be implemented during the period in district Hisar.

Now, in pursuance of order issued by the Haryana State Disaster Management Authority, Haryana, Chandigarh vide memo No. DMC-SPO-2020/13928, dated 24-12-2021 and in view of powers conferred me under the Section 30 and 34 of the Disaster Management Act, 2005, I, Dr. Priyanka Soni, I.A.S, Deputy Commissioner, Hisar and Chairman, District Disaster Management Authority, Hisar hereby extend the Mahamari Alert-Surakshit Haryana (महामारी अलर्ट-सुरक्षित हरियाणा) from 25-12-2021 (05:00 AM onwards) to 05-01-2022 (till 05:00 AM) in district Hisar alongwith guidelines to be implemented (during the

period) issued vide earlier orders.

The following modifications are provided in earlier orders:-

- 1. Night movement restrictions shall be strictly imposed from 11:00 PM to 05:00 AM in the District.
- 2. In indoor and open spaces, gatherings of upto 50% of the hall/area capacity will be allowed with a ceiling of maximum 200 persons/ 300 persons respectively subject to strict observance of COVID-19 appropriate behavioural norms and social distancing. It shall be the responsibility of Organisers of events to ensure that only fully vaccinated persons attend the events organised by them.
- 3. In all the public offices and facilities, only fully vaccinated persons are allowed to enter w.e.f. 01.01.2022.

However, the following guidelines shall continue as released vide earlier orders:-

- a. Restaurants, bars (including in hotels and in malls), gyms, spas and club houses/ restaurants/ bar of the Golf Courses are allowed to open with adherence to requisite social distancing and other COVID-19 appropriate safety norms.
- b. Cinema Halls (in malls and stand alone) are allowed to open with adherence to requisite social distancing norms, COVID-19 appropriate behavioural norms, the guidelines as indicated in the SOPs released by Ministry of Health and Family Welfare, GOI, as well as regular sanitisation of the premises.
- c. Fully residential Universities in the district are directed to plan re-opening their campuses for physical classes as per their respective Semester Schedules after adopting SOPs for COVID appropriate behaviour. University Administration may endeavour to get all students, faculty members and staff (including the outsourced ones) fully vaccinated.
- d. Colleges and Polytechnics are allowed to re-open for students with strict adherence to requisite social distancing norms, Covid appropriate behavioural norms, regular sanitisation of the premises, the guidelines as indicated in the SOPs released by Ministry of Health and Family Welfare, Gol and as per the guidelines of Department of Higher Education and Department of Technical Education.

Haryana released for implementation of these orders.

- e. Conduct of entrance and recruitment examinations by different Universities/Institutes/Government Departments and different Recruitment Agencies are allowed in the district with strict implementation of "Revised SOP issued by Ministry of Health and Family Welfare, GOI dated 10.09.2020 regarding preventive measures to contain spread of COVID 19" as well as guidelines Government/Departments time to time released by Central/State
- f. Training centers in District Hisar established under the aegis of Haryana Skill Development Mission are allowed to open (by staggering of the trainees for maintaining social distancing as per prescribed Standing Operating Procedures and Guidelines issued by Ministry of Home Affairs, GOI, State Disaster Management Authority, Haryana, National Skill Development Corporation and Local Administration from time to time).
- g. Coaching institutions, Libraries and Training Institutes (whether Government or private) are allowed to open with strict adherence to requisite social distancing norms, Covid appropriate behavioural norms guidelines as indicated in the SOPs released by Ministry of Health and Family Welfare, GOI and regular sanitisation of premises.
- h. Industrial Training institutes (ITIs) are allowed to open for students with 100% attendance with strict adherence to requisite social distancing norms, regular sanitisation of the premises. Covid appropriate behavioural norms and guidelines as indicated in the SOPs released by Ministry of Health and Family Welfare, GOI and guidelines of Department of Skill Development & Industrial Training, Haryana released for implementation of these orders.
- i. All shops and malls are allowed to open with adherence to requisite social distancing norms, regular sanitisation and COVID-19 appropriate behavioural norms.
- j. Swimming Pools are allowed to open after adopting requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms. All swimmers/ practioners/eligible visitors and staff to preferably get vaccinated with both doses of COVID-19 vaccine.
- k. Sports Complexes, Stadia are permitted to open for sports activities Including for outdoor sports activities except contact sports. Sports Authorities shall ensure adherence to requisite social distancing norms, regular sanitisation of the premises and COVID-19 appropriate behavioural norms.
- 1. Religious places are allowed to open with 50 persons at one time with the condition that they shall follow requisite social distancing norms, regular sanitisation and COVID-19 appropriate behavioural norms.
- m. Corporate Offices are permitted to open with full attendance subject to strict observance of social distancing, COVID-19 appropriate behavioural norms and regular sanitisation.
- n. All production units, establishments, Industries are permitted to function. However they shall strictly adhere to COVID-19 appropriate and prescribed guidelines, behavioural norms and Social distancing.

It is also advised that "No Mask-No Service" will be strictly observed in the District. People with face cover/mask only will be allowed to board public/private transport and enter any other government and private establishment for availing any services/goods.

There will be continuous focus on the fivefold strategy for effective management of COVID-19 i.e. Test-Trace-Track-Vaccination and adherence of COVID-19 appropriate behaviour.

The Sub Divisional Officers (C), will be overall incharge in their jurisdiction to keep the regular surveillance of every activity and will ensure strict enforcement of this order in rural areas also. Incident Commander shall ensure enforcement in their assigned duty area.

The Deputy Inspector General-cum-Superintendent of Police, Hisar & Superintendent of Police, Hansi shall constitute inspection teams for regular vigilance for implementation of this order.

This order shall be promulgated in the area of District Hisar (except for the areas declared as containment zones by this office) by beat of drum, by announcement through the publicity van of Public Relations Department and by means of mass communication like Radio, television, Social media and press release etc

All the concerned are hereby ordered to comply with the directions above. Any violation of these instructions/orders shall be punishable under provisions of section 51 to 60 of Disaster Management Act, 2005 as well as under Section 188 of the Indian Penal Code, 1860 as well as National directives and the offences and penalties for violating measures, as enclosed with MHA order dated 23-03-2021.

This order shall be implemented from 25-11-2021 (05:00 AM onwards).
