The Vice-Chancellor, CCS Haryana Agricultural University, Hisar is pleased to appoint **Mr. Vikas Lamba S/o Sh. Ved Parkash Village Harigarh PO Ramnagar Distt. Jind-126112** to the temporary post of Mechanic (Ref. & AC) under ESM (Gen.) category in the Instrumentation Cell, COAE&T in the scheme T-8-Agri(B) State in the pay scale of Rs. 5200-20200+2400 GP (revised to level-4) at a starting salary of minimum pay per month plus other allowances as admissible according to the rules of the CCS HAU, Hisar, as applicable from time to time, w.e.f. the date he/she reports himself/herself for duty on the following usual terms & conditions:-

He /She shall be:

- a) on probation for a period of two years which period may be extended or reduced by the competent authority. In case his/her work or conduct is not found to be satisfactory at any time during the period of probation, his/her services may be dispensed with, without any notice.
- b) required to produce Medical Certificate of fitness from the Senior Medical Officer of the University before he/she is allowed to join.
- c) required to pass Departmental Examination and such other tests as are/may be prescribed by the Vice-Chancellor from time to time.
- d) liable to transfer to any other post/work, without affecting his/her emoluments, at any time as and when it is considered necessary by the competent authority. It will also be open to the University to depute him/her to work elsewhere for specific periods.
- e) required to produce before joining, relieving certificate from his/her present employer, if any.
- f) entitled to leave, gratuity, T.A. and other allowances etc. according to the provisions of the Statutes and orders as are in force or amended/issued from time to time.
- g) governed by other conditions of services in accordance with the Statutes of this University and such other rules and orders as are in force or may be amended/introduced from time to time.
- h) liable to removal from service and such other action as may be deemed necessary, if any declaration given or information furnished by him/her is false or if he/she is found to have willfully suppressed any information.
- i) liable to removal from his/her service, in case subsequently any adverse facts come to the notice of the University as his/her character and antecedents have not been got verified.
- j) governed by the New Defined Contributory Pension Scheme amended/issued from time to time.
- k) required to produce at the time of joining, if applicable, a self attested statement to the effect that if at any stage the information provided in the proforma for socio-economic criteria filled by him/her is found to be false, his/her services will be terminated on the ground of furnishing wrong information. This termination of service shall be done even if he/she would have made to the selection list without the marks for socio-economic criteria. In addition, criminal action for giving false information in the form of self attested statement shall be initiated against him/her.



- l) liable to give his/her consent within 15 days from the date of issue of this letter to the Office/Department assigned to him whether the offer is acceptable to him or not. If no consent is received by this period, it will be presumed that the offer is not acceptable to him and steps will be taken to offer the post to the next candidate(s). If the offer is acceptable to him, he/she may join the post within six weeks from the date of issue of appointment orders failing which the offer of appointment will stand withdrawn.

2- The appointment of the above candidate is in anticipation of verification of academic certificates degrees/diplomas/caste/experience certificates etc. from the concerned issuing authorities with the condition that his/her service can be dispensed with, without any notice in case his/her certificates are found false/forged.

3- At the time of joining of duty, the ESM candidate of Haryana claiming benefit, will submit the valid Eligibility Certificate (in original) from the concerned Zila Sainik Board and the ESM candidate will also submit attested copy of identity card issued by concerned Zila Sainik Board.

4- The post stands cleared by the Vice-Chancellor, CCS HAU, Hisar. The candidate will be allowed to join the post only when he/she produces the Medical Certificate of fitness from the Senior Medical Officer, CCS HAU, Hisar and a self attested statement (if applicable) as mentioned under point (k) of para-1 in the appointment order.
