ORDER

Whereas information has been laid before me that Omicron variant (COVID-19) continues to spread around the country and persistent rise in COVID-19 cases, which is dangerous to human life. In the light of this fact, proper vaccination and prevention appears to be the best cure available so far. The Government of Haryana has framed the Haryana Epidemic Disease, COVID-19 Regulations 2020 to avoid the spreading of Corona Virus (COVID-19). Whereas in exercise of the powers under rule 12.9 of the Epidemic Disease Act, 1897 (as amended from time to time), directions/order issued by the Chief Secretary to Govt. of Haryana and Chairperson State Executive Committee, Haryana State Disaster Management Authority, Chandigarh vide memo No. DMC-SPO-2020/14198 dated 01.01.2022 and notification issued by Director General, Health Services Haryana vide No.32/3-IDSP-020/3318-24 dated 27.05.2020 regarding wearing of face mask mandatory for every person, for strict compliance to take effective measures so as to prevent the spread of COVID-19. Therefore, it is imperative to wear face masks, adopt strict social distancing and isolation measures to contain the spread of COVID-19. It is also necessary to ensure that no inconvenience is caused to the public in the district of Hisar.

Whereas, the Director General Health Services, Haryana has issued following directions vide Notification No. 32/3-10SP-020/3318-24 dated 27-05-2020 (copy enclosed):-

1. The Central Government and the State Government have made it very clear that in the interest of Public Safety during the prevailing of pandemic, wearing of a Face Cover whether a mask, an improvised mask, a home-made mask or a face cover using clean clothes shall be mandatory, for every person while being in public place and a workplace also.
2. Also there needs to be strict prohibition of spitting in public places.
3. New, therefore, it is ordered that every violation of the above these prohibitions will be punished by imposing fine of Rs. 500/- Non-payment of fine by the violator, he/she will be liable for punishment under section 188 of the Indian Penal Code.

The notification No. 32/3-10SP-020/3318-24 dated 27-05-2020 empower undersign to designate officers for implementation of these guidelines. Accordingly, every officer designated below shall be responsible for implementation of these directions:-


1. Additional Deputy Commissioner, Hisar.
2. City Magistrate, Hisar.
3. All Sub-Divisional Magistrate of District Hisar.
4. Joint Commissioner, Municipal Corporation, Hisar.
5. Deputy Municipal Commissioner, MC, Hisar.
6. All Deputy Superintendent of Police (DSP), in Police District Hisar/Hansi.
7. All Tehsildar and Naib Tehsildar, in District Hisar.
8. All BD&PO, in District Hisar.

9. All Executive Officers/Secretaries of Municipal Committees/ Corporations District Hisar.
10. Station House Officers.
11. Medical officers as designed by concerned Civil Surgeon for concerned Hospital/CHC/PHC premises.
12. All Heads of Officers in the District Hisar.
13. All Incident Commanders of Covid-19 in the Hisar District.
14. All Sanitary Inspector, in all U.L.B, in the Hisar District.
15. All Incharge of Police Posts, in Police District Hisar/ Hansi.
16. All PCR incharges, in Police District Hisar/ Hansi.
17. All Incharge Durga Shakti, in Police District Hisar/ Hansi.
18. NGOs posted in traffic Police Station, in Police District Hisar/ Hansi.

Also directions / order issued by the Chief Secretary to Govt. of Haryana and Chairperson State Executive Committee, Haryana State Disaster Management Authority, Chandigarh vide memo No. DMC-SPO-2020/14198 dated 01.01.2022 that the violators of COVID-19 appropriate behaviour including wearing of masks, social distancing and persons (adults) who have not received any COVID-19 vaccination dose or due for 2nd COVID-19 vaccination dose, shall be imposed a fine of Rs.500/- by issuing a Challan, Institutional violators shall be imposed a fine of Rs. 5000/-. Similarly, non-payment of fine and major violations will attract proceedings under the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.

Whereas it has been made appear to me that there is a need to enforce the orders strictly in the jurisdiction of district Hisar to prevent the transmission of the said virus being dangerous to human life. I am satisfied from the material placed before me that there are sufficient grounds for proceedings under section 144 of the Code of Criminal Procedure, 1973, and that immediate prevention is desirable and the situation if not properly checked immediately may lead to undesirable consequences paralyzing the peaceful atmosphere, orders in this regard have already been passed vide Order No. 14061-140/MA dated 01.01.2022.

All the above designated officers are directed to collect challan book from the Civil Surgeon, Hisar and ensure that all the challans are done through this challan book only. All the above designated Officers shall also ensure that challan amount shall be deposited in Treasury under 0210-01-800-92- other items head or in the office of Civil Surgeon, Hisar. Civil Surgeon, Hisar shall ensure that weekly settlement report shall be submitted to the District Nazam Branch, DC Office Hisar (E-mail ID dchsr@hry.nic.in) of this office.
