MEMORANDUM OF UNDERSTANDING BETWEEN CCS HARYANA AGRICULTURAL UNIVERSITY HISAR



AND

ICAR-CENTRAL INSTITUTE FOR RESEARCH ON BUFFALOES, HISAR



Memorandum of Understanding Between Chaudhary Charan Singh Haryana Agricultural University, Hisar and ICAR-Central Institute for Research on Buffaloes, Hisar

PREAMBLE

This Memorandum of Understanding (MOU) is made between Chaudhary Charan Singh, Haryana Agricultural University (hereinafter called CCS HAU) with its headquarter at Hisar as first party and ICAR-Central Institute for Research on Buffaloes, Hisar, herein called "CIRB." as second party. Whereas the parties, which wish to establish a friendly relationship to promote and accelerate the programmes of skill development for the farmers/members of SC community, have decided to enter into this MoU and agree, hereby as per articles given below.

Article -I

The Parties hereby, agree to promote the development of cooperation for organization of skill trainings under SCSP programme with their responsibilities as under:

i. The CCS, HAU is organizing trainings regularly in the scheme "Entrepreneurship and skill development", of scheduled caste candidates. At present, they are conducting trainings in different areas like value added milk products, preservation of fruits and vegetables, tailoring, mushroom production, value addition of cereals and pulses, organic farming, bee keeping, jewellery and handicraft for the skill development of schedule caste candidates. Thus, the university faculty has requisite expertise and experience in organizing such trainings. Therefore, in order to provide best services under SCSP programme, ICAR-CIRB would like to collaborate with CCS, HAU to conduct these trainings.

- ii. ICAR-CIRB would meet out all the expenses which are going to be incurred in organising these trainings while the SNAITTE (CCSHAU) shall provide all the facilities including their faculty venue and infrastructure for organising these trainings. Once the terms and conditions are agreed by both the parties money will be transferred in the official account of CCSHAU. After the completion of each training program CCSHAU will provide ICAR-CIRB with the audit utilization certificate.
- iii. The coordinators of trainings shall be from the CCS HAU and ICAR-CIRB. ICAR- CIRB would be expected to make reasonable contribution as and when required.
- iv. Training schedules will be prepared jointly by SNIATTE, CCS HAU and ICAR-CIRB, ICAR-CIRB, shall be included in the list of resource persons whenever required.
- v. The list of candidates to be included in a training programme shall be finalized jointly by SNAITTE (CCS HAU) with ICAR-CIRB.
- vi. Both the parties may ensure that only SC candidates are included in the training programme and requisite documents establishing the identity of the candidates shall be maintained by both the collaborating parties.
- vii. Intellectual property rights, research publications and benefits arising out of collaborative work if any under this agreement shall be jointly owned/shard by CCS-HAU and ICAR-CIRB.

Article-II

The parties may, by mutual consent, add, modify, amend or delete any word, phrase, sentence, or article in this MoU at any time during the operation of MoU as deemed fit in the true spirit for execution of project.

Article-III

This MoU shall be effective from the date of its signing by both the parties and shall remain in operation for five years until either party serves notice on the other of its intention to terminate it. In that case, the MoU shall be terminated at the end of one calendar month from the date of issue of such a notice.

Article-IV

The parties would act strictly according to the relevant provisions of law while implementing this MoU. The place of jurisdiction will be at Hisar, Haryana.

Article-V

The parties would act strictly according to the relevant provisions of law while implementing this MoU. All questions related to this MoU arising during its term will be settled by the parties by mutual agreement. In case of any dispute that may crop up during execution of MoU the matter would be settled through arbitration by referring it to a committee appointed by the parties on mutual consent.

This MoU has been executed in two originals, one of which has been retained by the First party and the other by the Second party.
