THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN

- 1. National Agri- Food Biotechnology Institute (NABI) (autonomous institute of Department of Biotechnology, GOI), Sector-81 Knowledge city, Mohali, Punjab, India (hereinafter referred to as "NABI" the context otherwise includes their respective nominees, legal representatives and successors);
- 2. Chaudhary Charan Singh Haryana Agricultural University (CCSHAU), a State Agricultural University located at Hisar, Haryana, India.

To promote the research cooperation between the two institutes.

Objectives:

- 1. NABI and CCSHAU will undertake joint research work including student's research in the areas of mutual interest.
- 2. The concerned scientists of NABI and CCSHAU will formulate research projects with due approval of competent authorities of both the institutes.
- 3. Impart training to staff, students and technical personnel within the areas of cooperation.
- 4. Keeping in view the interest and objectives of both the institutes, NABI and CCSHAU may apply for joint project under extramural grant schemes.

Sharing of facilities and outcome:

Both NABI and CCSHAU jointly agree

- 1.To share their respective research and development (R&D) facilities to carryout joint research projects.
- 2. To share laboratory, research farm, germplasm, library and other supporting facilities in the areas of joint research projects.
- 3. To share research results and publish jointly in collaborative projects.
- 4. Any IPR emerging from collaborative project will be the property of both the institutes in proportion to contribution of the investigators, as per Government of India rules.
- 5. In case of projects not supported formally by an extramural grant, but otherwise by the two institutes, the parties shall meet their respective, expenses (if available) which they might incur while carrying out their respective agreed obligation.
- Neither of the parties shall claim the usage of facilities/software or other services as a matter of right. It would be subject to availability, but would not be ordinarily refused.

Timeline:
