Subject: Instructions regarding mandatorily wearing face mask in public places.

With reference to the subject cited above,

It is intimated that in a meeting held under the chairmanship of Hon'ble Health Minister, Haryana on 03.04.2023, it has been observed that there is significant upsurge in the number of COVID cases with increased positivity rate of COVID-19 infection in the State of Haryana over past few weeks.

Accordingly, after examining all the relevant facts related to the threat of another possible outbreak of dangerous epidemic disease namely COVID-19, Government of Haryana in Health Department, exercising the powers conferred under Rule 12.9 of the Haryana Epidemic Diseases COVID-19 Regulations, 2020, issued under the Epidemic Diseases Act, 1897 and as amended from time to time, has decided that wearing of face mask by general public at all the public places, where there is a gathering of more than 100 people, government offices, malls, etc. is mandatory.

It is, thus, requested to ensure that it is implemented in all parts of Haryana State in true letter and spirit, and general public be motivated to adopt COVID appropriate behaviour in public places.
