# MEMORANDUM OF AGREEMENT (MOA)

Between

# CCS HARYANA AGRICULTURAL UNIVERSITY HISAR, HARYANA, INDIA

and

# SWADESHI SHODH SANSTHAN

(An initiative of Swadeshi Swawlamban Nyas (Trust))

For the purpose of this MoA, herein CCS Haryana Agricultural University, Hisar shall be referred to as the 'University', and Swadeshi Shodh Sansthan (Swadeshi Swawlamban Nyas (Trust)), shall be referred to as the 'Trust.'

CCS Haryana Agricultural University, Hisar herein referred to as First Party, and Swadeshi Shodh Sansthan (Swadeshi Swawlamban Nyas (Trust)) hereinafter referred to as Second Party and under the aegis of Swadeshi Swawalamban Nyas, New Delhi (hereinafter referred to as Third Party) enter into this Memorandum of Agreement (MoA) to pursue their common mutual interests through collaborative activities among academics, learners, researchers and social experts/activists/extension specialists for teaching, research and extension on the following subjects, terms and conditions.

1. Research: Both the parties agreed to exchange of faculty, students/research scholar and staff in the agricultural and allied areas/subjects like Agriculture, Agricultural Engineering, Community Science, Fishery Science, Biotechnology and Basic Science including Economics, Business administration, Commerce, Engineering & Technology, Sociology, Political Science and other Social Sciences. The University can send research scholars to Swadeshi Shodh Sansthan, New Delhi in the thrust areas of mutual interest. The scholars can stay at the Swadeshi Shodh Sansthan at free of cost. Trust can fund one research scholar by paying stipend, who is registered at the University and if he has no scholarship. The University will allot Supervisor to the researcher and TRUST can them co-supervisor from the provide list of its senior researchers/mentors. Researchers can use library and work place of the Sansthan. The Santhan has a good interaction/ access with many research institutes, Government ministries/offices and International institutions. The Sansthan will facilitate the researchers to visit or collaborate with these institutions. The Supervisors from the University can also visit and stay at TRUST for one week at a very nominal/concessional payment.

### 2. Collaborative areas

- Teaching, research, extension, entrepreneurship, training, and areas of mutual cooperation
- Organizing a series of extension lectures
- Organizing workshops, seminars and discussion meetings,
   Skill development, employment, and self-reliance of students.
- Value based education, national character building of students and their all-round development
- Other related subjects on mutual consent of the parties.
- 3. Training and management: The University and Trust will conduct training as per their own arrangements and both parties will be

- authorized to provide subject experts and course material. However, the Trust will also provide special support for its implementation.
  - **4. Eligibility:** Faculty, students and staff of the University are eligible to enter and participate in these programs.
    - 5. Advertisement and Media Publicity: Media publicity, if any, will be the responsibility of the Trust and the University.

## 6. Intellectual Property Rights:

- (i) The University and Trust will ensure appropriate protection of Intellectual Property Rights generated from cooperation pursuant to this MoA, consistent with their respective laws, rules and regulations and national agreements to which both parties are committed.
- (ii) In case research is carried out solely and separately by one Party or the research results are obtained through the sole and separate effort of one Party, the Party concerned alone will apply for grant of IPR and once granted, the IPR will be solely owned by the concerned Party.
- (iii) In case of research results obtained through joint activities, the grant of intellectual property rights will be sought by both Parties jointly and once granted these rights will be jointly owned by the Parties.
- (iv) The Parties shall not assign any rights and obligations arising out of the IPR generated to inventions/activities carried out under the MoA to any third party without the consent of the other Party.

#### **Publication:**

Any publication, document and/or paper arising out of joint work conducted by the Parties pursuant to this MoA will be jointly owned. The use of the name, logo and/or official emblem of the Parties on any publication, document and/or paper will require prior permission of both the Parties. It may however be ensured that the official emblem and logo is not misused.

#### **Confidential Information:**

- (i) All information and documents to be exchanged pursuant to this Memorandum of Agreement will be kept confidential by the Parties and will be used subject to such terms as each Party may specify. A Party will not use the information for purposes other than that specified without the prior written consent of the other Party.
- (ii) All Confidential Information shall remain the exclusive property of the disclosing Party. The Parties agree that the disclosure of the Confidential Information do not grant or imply any license, interest or right to the Recipient in respect to any intellectual property right of the other Party.

Unpublished information, whether oral, in writing or otherwise, discovered or conceived under the provisions of this MoA will not be transmitted to a third party, unless otherwise agreed by the Parties.

## 7. Financial Arrangements

For Training, consultancy and other activities mentioned in this MoA, the financial arrangements shall be decided by mutual consent of both the Parties prior to start of the event.

- Duration of MOA, Amendment, Termination and Dispute **Resolution:**
- (i) This MoA will be initially valid for a period of 5 (five) years from the date of signing.
- (ii) This MoA may be amended by mutual consent of both the parties expressed in writing.
- (iii) CCS HAU, Hisar and Swadeshi Shodh Sansthan (Swadeshi Swawlamban Nyas (Trust)), both shall have the right to terminate this MoA by giving three months written notice to the other party. Such termination shall not affect the activities already underway.
- (iv) Both the parties shall try to settle any dispute arising during the execution of this MoA amicably. In case of any dispute, jurisdiction shall be District Court, Hisar.
