Subject:- Subsidy on the sale of Certified seed during Rabi, 2003-10
under MMM and ISOPOM Scheme.

It is informed that subsidy will be provided on all kind of certified
seeds of Wheat, Barley, oilseeds and Pulses sold to the farmers in the State.

The rates of subsidy will be as under:-

Sr. No.	Crop	Rate of subsidy	Remarks
1-	Wheat	Rs.700/- per qtl.	Certified seeds of varieties not older than 15 years from the date of notification.
2-	Barley	Rs.1000/- per qtl.	Certified seeds of varieties not older than 15 years from the date of notification.
3-	Oilseeds and pulses Crop seed	50% of the cost of certified seeds or Rs.2000/- qtl.whichever is less.	Certified seeds only. No assistance will be provided for varieties already de-notified phased out.

Subsidy claim bills will be submit for claims to the concerned DDA
under whose jurisdiction the seed have been sold.

Crop	Name of Scheme	Rate of subsidy
Cotton (Certified Seed)	MM-II of TMC	25% of Market Price For Varieties/Hybrids And 50% of Market Price For Extra Long Staple Cotton in new areas.
Certified seed of Mash etc. Oilseeds, Pulses and Maize.	ISOPOM	50% of the cost of certified seed of all crops or Rs. 1200/-per qtl. Which ever is less.
