Its functions and duties are to impart vocational and SC/ST trainings to the farmers of the Sirsa District. DES help the farmers to solve their farm related problems. Also water and soil testing is carried out in this department. It owns 35 acres of agricultural land for seed production etc. Also imparts training for Crop Residue management. It also implements the task assigned by the ICAR and other funding agencies.
- (ii) To aid the farmers to eliminate their farm related problems and to look after its own land.
- (iii) The decision of CCS HAU, Hisar are implemented also Senior Coordinator makes its decision at local level in consultations with the DES.
- (iv) OFT and FLD and different trainings are provided to the farmers as per schedule and crop season.
