

DISTRICT ADMINISTRATION, HISAR

ORDER

Whereas, the COVID-19 pandemic is again posing threat to public health, District Administration has considered it necessary to take effective measures to prevent its spread in district Hisar. In compliance of order issued by the Haryana State Disaster Management Authority, Haryana, Chandigarh vide memo No. DMC-SPO-2020/5215, dated 02-05-2021, it was declared a lockdown from 03-05-2021 (05:00 AM onwards) to 10-05-2021 (till 05:00 AM) in District Hisar vide order No. 2008-2088/MA dated 03-05-2021, same was extended as **Mahamari Alert-Surakshit Haryana** (महामारी अलर्ट-सुरक्षित हरियाणा) from 10-05-2021 (05:00 AM onwards) to 17-05-2021 (till 05:00 AM), 17-05-2021 (05:00 AM onwards) to 24-05-2021 (till 05:00 AM), 24-05-2021 (05:00 AM onwards) to 31-05-2021 (till 05:00 AM), 31-05-2021 (05:00 AM onwards) to 07-06-2021 (till 05:00 AM), 07-06-2021 (05:00 AM onwards) to 14-06-2021 (till 05:00 AM), 14-06-2021 (05:00 AM) to 21-06-2021 (till 05:00 AM), 21-06-2021 (05:00 AM) to 28-06-2021 (till 05:00 AM), 28-06-2021 (05:00 AM) to 05-07-2021 (till 05:00 AM), 05-07-2021 (05:00 AM) to 12-07-2021 (till 05:00 AM), 12-07-2021 (05:00 AM) to 19-07-2021 (till 05:00 AM), 19-07-2021 (05:00 AM) to 26-07-2021 (till 05:00 AM), 26-07-2021 (05:00 AM) to 02-08-2021 (till 05:00 AM), 02-08-2021 (05:00 AM) to 09-08-2021 (till 05:00 AM), 09-08-2021 (05:00 AM) to 23-08-2021 (till 05:00 AM), 23-08-2021 (05:00 AM) to 06-09-2021 (till 05:00 AM), 06-09-2021 (05:00 AM) to 20-09-2021 (till 05:00 AM), 20-09-2021 (05:00 AM) to 04-10-2021 (till 05:00 AM), 04-10-2021 (05:00 AM) to 18-10-2021 (till 05:00 AM), 18-10-2021 (05:00 AM) to 14-11-2021 (till 05:00 AM), 14-11-2021 (05:00 AM) to 28-11-2021 (till 05:00 AM), 28-11-2021 (05:00 AM) to 31-12-2021 (till 05:00 AM), 25-12-2021 (05:00 AM) to 05-01-2022 (till 05:00 AM), and further from 02-01-2022 (05:00 AM onwards) to 12-01-2022 (till 05:00 AM) along with guidelines to be implemented during the period in district Hisar.

Now, in pursuance of order issued by the Haryana State Disaster Management Authority, Haryana, Chandigarh vide memo No. **DMC-SPO-2020/343, dated 10-01-2022** and in view of powers conferred me under the Section 30 and 34 of the Disaster Management Act, 2005, **I, Dr. Priyanka Soni, I.A.S, Deputy Commissioner, Hisar** and Chairman, District Disaster Management Authority, Hisar hereby extend the **Mahamari Alert-Surakshit Haryana** (महामारी अलर्ट-सुरक्षित हरियाणा) from **10-01-2022 (05:00 AM onwards) to 19-01-2022 (till 05:00 AM)** in district Hisar alongwith guidelines to be implemented (during the period) issued vide earlier orders.

1. The following restrictions are imposed in Hisar, being in Group 'A' district:-

- All cinema halls, theaters, multiplexes shall remain closed.
- All Sports complexes, stadia, swimming pools shall remain closed (except being used for training of sports persons for participation in National/International sports events as well as for organizing National/International sports events). No Spectators or visitors are to be allowed.
- All entertainment parks and B2B exhibitions are prohibited.
- Offices (Government and Private), except for emergency/essential services, are advised to function with 50% staff attendance.
- Bars and Restaurants are allowed to operate with 50% seating capacity.
- Malls and markets are allowed to open up to 06:00 PM. However, shops of essential supplies like milk/medical shops are allowed to open at all times to enable them to serve the public at large.
- Large congregations like all kinds of Public Meetings, Rallies, Protests, Dharnas, etc shall be prohibited in the Hisar District.

COVID-19 Vaccination:-

- Only fully vaccinated persons are allowed to enter at places like sabzi mandi, grain markets, public Transport (Bus Stand and Railway stations), parks, religious places, bars, restaurants, hotels, departmental stores, ration shops, liquor and wine shops, malls, shopping complexes, cinema hall, hants, local markets, petrol and CNG Stations, LPG gas cylinder collection centers, sugar mills, milk booths, yogshalas, gym, fitness centers, all Government/Board/Corporation offices, private and Government Sector banks. The onus of ensuring this will be on the owners/management of these institutions.
 - Truck and auto rickshaw unions shall allow only fully vaccinated persons.
 - COVID-19 Vaccination of eligible persons (more than 15 Years) is mandatory.
 - Citizens, who have received the 1st dose but the 2nd dose is not due, shall not come under above mentioned restrictions for mandatory 2nd dose (in case COVISHIELD beneficiary will be eligible for second dose after 84 days from first dose and in case of COVAXIN beneficiary will be eligible for second dose after 28 days from first dose). The following means may be considered for verifying the vaccination status:-
 - i. Downloaded certificates of 2nd dose (Hard/soft copies).
 - ii. 1st dose certificate to check if 2nd dose is due or not.
 - iii. Person not having smart phones, text message sent via COWIN portal (NHPSMS) may be considered for successful vaccination.
 - iv. Arogya Setu app to check vaccination status.
 - Adequate publicity of all above mentioned measures to be done by districts to ensure awareness among general public regarding making COVID-19 vaccination mandatory. Vaccination camps shall be arranged by concerned Sub Divisional Officer (C) in district Hisar. Health Department shall depute vaccination teams where and whenever demanded by the Sub Divisional Officer (C) for on spot vaccination or for regular vaccination camps at places of gatherings.
2. School, Colleges, Polytechnics, ITIs, Coaching institutions, Libraries and Training Institutes (whether Government or private). Anganwadi Centers and Creches under Woman and Child development Department shall remain closed in the District.
 3. NGOs and Urban Local Bodies Department are advised to distribute masks in the public.
 4. "No Mask-No Service" will be strictly observed in the district Hisar.
 5. The violators of COVID-19 appropriate behavior including wearing of masks, social distancing and persons adults) who have not received any COVID-19 vaccination dose or due for 2nd COVID-19 vaccination dose, shall be imposed a fine of Rs. 500/- by issuing a Challan. Institutional violators shall be imposed a fine of Rs. 5000, similarly. Non payment of fine and major violations will attract proceedings under the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.
 6. Night movement restrictions shall be continued from 11:00 PM to 05:00 AM in the district strictly.

There will be continuous focus on the five fold strategy for effective management of COVID-19 i.e. Test-Trace-Track-Vaccination and adherence of COVID-19 appropriate behaviour.

The Sub Divisional Officers (C), will be overall incharge in their jurisdiction to keep the regular surveillance of every activity and will ensure strict enforcement of this order in rural areas also. Incident Commander shall ensure enforcement in their assigned duty area.

The Deputy Inspector General-cum-Superintendent of Police, Hisar & Superintendent of Police, Hansi shall constitute inspection teams for regular vigilance for implementation of this order.

This order shall be promulgated in the area of District Hisar (except for the areas declared as containment zones by this office) by beat of drum, by announcement through the publicity van of Public Relations Department and by means of mass communication like Radio, television, Social media and press release etc.

All the concerned are hereby ordered to comply with the directions above. Any violation of these instructions/orders shall be punishable under provisions of section 51 to 60 of Disaster Management Act, 2005 as well as under Section 188 of the Indian Penal Code, 1860 as well as National directives and the offences and penalties for violating measures, as enclosed with MHA order dated 23-03-2021.

This order shall be implemented from 10-01-2022 (05:00 AM onwards).
