

**MEMEORANDUM OF UNDERSTANDING**  
**BETWEEN**  
**PUNJAB NATIONAL BANK-FARMERS TRAINING CENTRE (PNB-FTC)**  
**SACCHA KHERA DISTRICT, JIND (HARYANA)**  
**AND**  
**CHAUDHARY CHARAN SINGH HARYANA AGRICULTURAL UNIVERSITY, HISAR**  
**(CCSHAU, HISAR)**

**PREAMBLE**

This Memorandum of understanding (MOU) is made between Punjab National Bank Farmers Training Centre (PNB-FTC), Saccha Khera Distt-Jind, Haryana--(hereafter called PNB-FTC), as first party and Chaudhary Charan Singh, Haryana Agricultural University (hereinafter called CCSHAU) with its headquarter at Hisar as second party. Whereas the parties, which wish to establish collaboration for upgrading of skills of farmers through trainings. CCSHAU, Hisar is charged with its responsibility of facilitating the services of Scientist/Experts/Master Trainers as per term and conditions in the MOU. PNB-FTC, Saccha Khera will provide all teaching facilities and training aids of quality to make the communication between the trainers and trainees an effective one in the area of mutual concern. Both the parties have decided to enter into this MOU as per articles given below:-


**Article-I**

The parties hereby agree to enter into collaboration with the objectives of the project as under:

- Establish mutual relations between farm training services divisions of respective parties.
- Great facilities for imparting quality training of farmers in the field of agriculture and allied disciplines to safe-guard the mutual interest.

**Article-II**

The CCSHAU, Hisar and PNB-FTC may name any member of their to develop suitable work plan and to work out practical details farmer's training in general to ensure proper and effective implementation of this agreement.



### Article-III


A joint Project Management Committee will consist of Director Extension Education, CCSHAU, Hisar and Director, PNB-FTC. They will meet periodically to follow up the execution of this MOU and suggest necessary measures for its implementation and development of annual/monthly workplan to be prepared which describe the activities to be undertaken. The workplan may originate with either party but will require full approval of both parties for implementation. Further if any dispute, it will be solved by a Joint Committee consisting of Director Extension Education, CCSHAU, Hisar and Director, PNB-FTC. In case both the parties do not reach any consensus the final decision will be taken by Director, PNBFTC, Sacha Khera and Vice-Chancellor, CCSHAU, Hisar.

### Article-IV

Both parties will work to establish inter-institutional linkage between CCSHAU, Hisar and PNB-FTC. The parties may, by mutual consent, add modify, amend or delete any word, phrase, sentence, or article in this MOU at any time during the operation of MOU.

### Article-V

1. CCSHAU, Hisar will facilitate the organization of Farmer's Trainings by providing expert master trainers at Saccha Khera depending upon the annual/monthly action plan.
2. PNBFTC will make provision for the payment of overhead/service charges ₹.1,00,000/- (Rupees One Lakh only) to the CCSHAU, Hisar and conveyance charge ₹.1500/- (Rupees One Thousand Five hundreds only) per visit to the scientists/experts/master trainers. The scientists/experts/master trainers will be provided by CCSHAU, Hisar. The physical facilities (training aid etc.) for arranging lecture and conducting practical will be solely arranged by PNB-FTC, Saccha Khera.
3. PNB-FTC will send his requirements one month advance of the actual date of commencement of Training programme to Director Extension Education, CCHAU, Hisar or his Nominee.
4. CCSHAU, Hisar will only work as service provider for organization of farmer's training programmes and shall not be responsible for any legal implication at any stage, if any. To





avoid such implications PNB-FTC, Saccha Khera will depute Senior Manager/Director to monitor training programmes at Sacha Khera for its smooth conductance.

5. The requirement and other facilities are need-based and may change depending upon the type of training. PNB-FTC, Saccha Khera will make necessary arrangements for training well in advance as per requirements.
6. The total number of days of visits of scientists/experts/master trainers for one year would be 80 (approximately).

#### Article-VI

This MOU shall be effective from the date of its signing by both the parties and shall remain in operation for two years until either party serves notice on the other of its intention to terminate it. In that case, the MOU shall be terminated at the end of one calendar month from the date of issue of such a notice.

#### Article-VII

The parties would act strictly according to the relevant provisions of law while implementing this MOU. The place of jurisdiction will be at Hisar, Haryana.

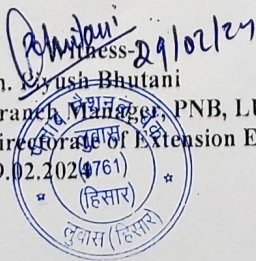
