## DISTRICT ADMINISTRATION, HISAR

## **ORDER**

Whereas, the COVID-19 pandemic is again posing threat to public health, District Administration has considered it necessary to take effective measures to prevent its spread in district Hisar. In compliance of order issued by the Haryana State Disaster Management Authority, Haryana, Chandigarh vide memo No. DMC-SPO-2020/5215, dated 02-05-2021, it was declared a lockdown from 03-05-2021 (05:00 AM onwards) to 10-05-2021 (till 05:00 AM) in District Hisar vide order No. 2008-2088/MA dated 03-05-2021, same was extended as **Mahamari Alert-Surakshit Haryana** (महामारी अलर्ट-सुरक्षित हरियाण) from 10-05-2021 (05:00 AM onwards) to 17-05-2021 (till 05:00 AM), 17-05-2021 (05:00 AM onwards) to 24-05-2021 (till 05:00 AM), 24-05-2021 (05:00 AM onwards) to 31-05-2021 (till 05:00 AM), 31-05-2021 (05:00 AM onwards) to 07-06-2021 (till 05:00 AM) along with guidelines to be implemented during the period in district Hisar.

Now, in pursuance of order issued by the Haryana State Disaster Management Authority, Haryana, Chandigarh vide memo No. DMC-SPO-2020/6415, dated 13-06-2021 and in view of powers conferred me under the Section 30 and 34 of the Disaster Management Act, 2005, I, Dr. Priyanka Soni, I.A.S, Deputy Commissioner, Hisar and Chairman, District Disaster Management Authority, Hisar hereby extend the Mahamari Alert-Surakshit Haryana (महामारी अलर्ट-पुरक्षित हरियाणा) for another week i.e. from 14-06-2021 (05:00 AM onwards) to 21-06-2021 (tills 05:00 AM) in district Hisar alongwith guidelines to be implemented (during the period) issued vide orders dated (DMC-SPO-2020/5215) dated 02-05-2021 and modified subsequently vide orders dated 09-05-2021 (DMC-SPO-2020/5439), 16.05.2021 (DMC-SPO-2020/3093), 23.05.2021 (DMC-SPO-2020/6761), 30.05.2021 (DMC-SPO-2020/6008) and 06.06.2021 (DMC-SPO-2020/6222).

All colleges, coaching institutions, ITIs, Libraries & Training Institutes whether Government or private shall remain closed till further orders in the district.

However the following relaxations are provided in modification of earlier order issued vide DMC-SPO-2020/6222 dated 06.06.2021:-

- a) All Shops are allowed to open from 09:00 AM to 08:00 PM.
- b) Malls are allowed to open from 10:00 AM to 08:00 PM.
- c) Restaurants and bars (including in hotels and in malls) are allowed to open from 10:00 AM to 10:00 PM with 50% of the seating capacity and adopting requisite social distancing norms, regular sanitization and Covid appropriate behavioural norms. Home delivery from notels, restaurants and fast food joints is permitted upto 10:00 PM.
- d) Religious places are allowed to open with 21 persons at one time with the condition that they follow requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms.
- e) Corporate Offices are permitted to open with 50% attendance after adopting requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms.
- f) Gatherings in weddings, Funerals/Cremations are allowed upto 21 persons. However weddings can take place at places other than home and Courts also. No movement of 'Barat' procession will be allowed.
- g) For gatherings other than weddings, funerals/cremations, the maximum number allowed will be 50. For gatherings morethan 50, prior permission from the concerned Sub-Divisional Magistrate shall be required.

- Club houses/ restaurants/ bars of the Golf Courses are allowed to open with 50% seating capacity from 10:00 AM to 10:00 PM with adherence to requisite social distancing and other safety norms. Members/visitors shall be allowed to play in Golf Courses by the management in a staggered manner so as to avoid overcrowding.
- i) Gyms are allowed to open from 06:00 AM to 08:00 PM with 50% capacity after adopting requisite social distancing norms, regular sanitisation and covid appropriate behavioural norms. However Spas shall remain closed.
- j) All production units/establishments, industries are permitted to function. However, they shall strictly adhere to Covid appropriate and prescribed guidelines, behavioual norms.
- k) Sports complexes, Stadia are permitted to open only for sports activities(Spectators will not be allowed.) Sports Authorities shall ensure adherence to requisite social distancing norms, regular sanitisation of premises and Covid appropriate behavioural norms.

The Sub Divisional Officers (C), will be overall incharge in their jurisdiction to keep the regular surveillance of every activity and will ensure strict enforcement of this order in their Sub-Division. Incident Commander shall ensure enforcement in their assigned duty area.

The Superintendent of Police, Hisar/Hansi shall constitute inspection teams for regular vigilance for implementation of this order.

This order shall be promulgated in the area of District Hisar (except for the areas declared as containment zones by this office) by beat of drum, by announcement through the publicity van of Public Relations Department and by means of mass communication like Radio, television, Social media and press release etc.

All the concerned are hereby ordered to comply with the directions above. Any violation of these instructions/orders shall be punishable under provisions of section 51 to 60 of Disaster Management Act, 2005 as well as under Section 188 of the Indian Penal Code, 1860 as well as National directives and the offences and penalties for violating measures, as enclosed with MHA order dated 23-03-2021.

This order shall be implemented from 14-06-2021 (05:00 AM onwards).
